Scenario 1

Annette and Chung met when they were both studying law at university. They married 30 years ago and have no children. Annette qualified as a barrister and specialised in commercial law. She now earns £200,000 a year. Chung was less successful. Over the years, Chung had been employed in a number of low paid jobs and, eventually, Annette agreed that Chung should give up work. They bought an old farmhouse and Chung has spent the last 15 years improving the property. It is now estimated to be worth £1,000,000.

Although Annette has put a substantial amount of money into her pension, Annette and Chung have no savings. They have spent considerable money on designer clothes and luxury holidays. Chung has no pension provision.

A year ago, Annette admitted to Chung that she had been having a sexual relationship with Bernard, a work colleague, but she told him that the relationship with Bernard had now ended. Annette and Chung then agreed to give their marriage a second chance.

Following this decision, Chung had thought that all was going well until a couple of months ago, when Annette started staying out late. Whenever Chung asked Annette where she had been, she became abusive and said that she had to work late because he does not contribute financially.

Recently, Annette said that she was going away for a weekend with a female friend. When Chung rang her mobile phone, a man answered and refused to say who he was. Annette denied that she had spent the weekend with a man.

Annette has now said that she no longer wants to be married to Chung. She has also said that they should sell the house and has told Chung that, as she earned all the money, she should receive all of the sale proceeds.

Scenario 2

Jason and Ellie met six years ago while travelling. At the time, Jason was 21 and Ellie, 17. They were immediately attracted to each other and on impulse they went through an informal marriage ceremony in Bali.

Jason and Ellie completed their travels and when they returned to the United Kingdom, they bought a flat and set up home together. Ellie's parents gave her the money to pay half the deposit but the flat was registered in Jason's name only as Ellie was too young to obtain a mortgage.

Two years ago, Jason and Ellie had a daughter, Bea. Six months after giving birth, Ellie returned to work and Ellie's mother looked after Bea while Ellie was at work. Ellie missed being with Bea. She found the pressure of being the mother of a young child and working full time increasingly stressful. Although Jason loved Bea and was good at looking after her, he also expected his life to continue much as before, working as a sports coach and enjoying time with his friends at weekends. He did not help Ellie with cleaning, cooking or shopping. This led to arguments, which have increased over recent months.

Last week, Jason told Ellie that he realised their relationship had been a mistake. He felt that they were both too young when they made the commitment and that they should now separate. Jason said that he had just been offered a job managing a leisure centre in another town so he intended to sell the flat and move away.

This week, Ellie told Jason that she has joined a new religious movement, which requires members to live separately from mainstream society. Ellie said that she is planning to take Bea to live at one of their religious centres and that Jason might not see Bea again. Ellie also said that as she had not named Jason as Bea's father on the birth certificate, he could not stop Ellie from moving and taking Bea with her.

Jason is concerned for Bea's welfare.

Scenario 3

Peter and Ria have been married for 15 years. They separated three years ago by agreement. They both belong to a religious sect that believes that marriage can be ended only by death.

Ria lives in the family home with their three children, Zelda, age 14, Yvonne, age 12 and Vera, age five. Peter now lives in a three-bedroomed rented flat. Peter has seen the children on a regular basis since he separated from Ria.

Zelda, who has learning difficulties, has recently been diagnosed with a blood disorder and her doctor has advised that she should have a blood transfusion. Zelda has previously suggested that she does not want to have a blood transfusion.

Ria says that blood transfusions are against her religious beliefs and has told the doctor that she will not agree to the treatment taking place. Despite his religious beliefs, Peter wants Zelda to have the blood transfusion.

Since Peter and Ria have been arguing over Zelda's medical treatment, Ria has refused to let him see any of the children. Peter is concerned that Ria is ignoring the needs of Yvonne and Vera as she focuses on Zelda all the time. He has recently received a text message from Yvonne, asking if she can come to live with him.

The family home is worth £500,000 and has no mortgage on it. Peter wants the family home to be sold and the proceeds shared. This would enable him to buy his own house so that the children could stay with him for longer periods of time.
