Guidance and Information notes for applicants – CILEX Lawyer Scholarship Programme

Please ensure you read this guidance in full, before starting the application process for the CILEX Lawyer Scholarship Programme.

1. What is the CILEX Foundation

- 1.1. The CILEX Foundation is a registered Charity (registered charity number 1185862) that supports CILEX Members, whether they are qualified CILEX Lawyers or CILEX Paralegals, non-practicing members or students studying the CILEX route to law.
- 1.2. One of the charitable aims of the CILEX Foundation is to encourage and support members of under-represented groups to study Law and progress within the legal sector. We do this by offering means-tested awards of academic fees and associated costs, to students enrolling with a <u>CILEX</u> Accredited Learning Provider.

2. What is a CILEX Lawyer Scholarship?

- 2.1. A CILEX Lawyer scholarship provides funding to study the CILEX Professional Qualification (CPQ). On completion of this qualification, you will have gained a recognised qualification in Law, valuable work experience and desirable skills in legal practice, professionalism and ethics.
- 2.2 More information on the CILEX route to law can be found here.
- 2.3 Awards are made following an assessment process and are awarded at the charity Trustee's discretion.
- 2.4 If awarded a scholarship, and on becoming a CILEX Lawyer scholarship student, the CILEX Foundation will fund:
 - The course fees of the CILEX Professional Qualification (CPQ) Foundation, Advanced and Professional Stages.
- 2.5 Scholarship students will be expected to maximise the opportunity this funding gives them, by striving for academic excellence and taking full advantage of the learning and career development opportunities the scholarship will provide them.

3. Additional support for CILEX Lawyer scholarship students

- 3.1 As a CILEX Lawyer scholarship student, you may be eligible for additional opportunities or benefits provided by our donors and supporters. This could include information on additional training or internships, employability coaching, career mentors or other items and activities geared toward optimising your study experience. Please note that no extra-curricular activity is guaranteed as part of the scholarship offer.
- 3.2 Additionally, The CILEX Foundation may, on occasions, make additional awards towards the costs

of Memberships fees payable to CILEX, costs associated with registering to study with an Accredited CPQ provider, equipment, materials or other costs that would assist the scholarship student in completing their studies. These awards are made as part of the CILEX Foundation's Welfare and Support Programme, at the strict discretion of the Trustees of the CILEX Foundation. 3.3 You may be asked to promote the work of the charity and support the CILEX Lawyer Scholarship Programme as an ambassador in future events. The Charity Support Officer will discuss this with you as individual opportunities arise.

4. Who is eligible for a CILEX Lawyer scholarship?

- 4.1 The CILEX Foundation Trustees seek to award scholarships to candidates who can demonstrate:
 - That the cost of study is a barrier to accessing the CPQ qualification,
 - That they might experience challenges or barriers in accessing Legal education and training,
 - That are eligible to enrol on the CILEX Professional Qualification, starting at the Foundation Stage.
- 4.2 Details of the CPQ Foundation stage specification and requirements can be found here.
- 4.3 Before applying, we recommend that applicants read our eligibility criteria assessment guidelines below, to consider how this eligibility may be assessed:

To be assessed as eligible for a CILEX Lawyer scholarship, applicants must satisfy <u>any</u> of the financial eligibility criteria in Part A, plus any of the criteria relating to barriers in Part B.

Applicants may be required to produce documentary or supporting evidence to support their eligibility at any stage of the application process.

- 4.3 If you are unsure of your eligibility or the documentation required to support your application, please contact the Charity Support Office using the General Enquiry Forms.
- 4.4 Only applicants who are resident in England or Wales can be considered for a CILEX Lawyer Scholarship.

5. How do I apply?

5.1 To apply online, you will need to create a MyCILEX account. The application form can be found on the CILEX Foundation area of the MyCILEX portal.

5.2 You do not need to enclose any supporting documentation at the application stage.

6. How are applications assessed?

- 6.1 You will be asked to complete an online application form confirming your eligibility. This form will also ask you for information on your motivation for applying for the scholarship and your interest in becoming a CILEX Lawyer.
- 6.2 It is important that you complete the form honestly, and to the best of your ability. The information you provide in the form will be used to determine your eligibility for the scholarship funding, as well as being used to shortlist you against other eligible candidates.
- 6.3 Personal information and information used to monitor equality and diversity may be removed to ensure applications are assessed fairly. Forms will be anonymised before they are sent for shortlisting.
- 6.4 The Scholarship scheme is expected to be in very high demand, and meeting eligibility criteria does not guarantee entry onto the scheme. To allow for the scheme to be administered fairly and for the broadest range of applicants to benefit, candidates will be asked to attend an interview currently virtually by Microsoft Teams or other video calling platform. Contact will be made by the Charity Support Office with full details in this event. You may be asked to provide references to support your application. Details of how these should be obtained will be provided to you at the applicable stage of the process.
- 6.5 Awarding decision will be made by a panel of Trustees of the Board of the CILEX Foundation.

7. What if I need support with my application?

- 7.1 If you require support or assistance in completing the application form, please contact the Charity using the General Enquiry forms.
- 7.2 If you think you may require reasonable adjustments to any part of the application process, please contact us to discuss how we can support you to apply.

8. When can I apply?

8.1 The CILEX Lawyer Scholarship programme application period for 2023 opens on 2nd May 2023. The application period will close at 5pm on 2nd June 2023. Applications received after this date cannot be considered.

9. What if I have applied before?

9.1 Funding cycles are annual. If you wish to be considered for the next funding cycle, you will need to make a new application, submitting up-to-date information confirming your eligibility. The CILEX Foundation does not operate a reserve or clearing list and will not retain applications for future use.

11. Continued receipt of a scholarship

11.1 Scholarships may be withdrawn, or payments withheld if you no longer meet any specific course requirements, specific grade progression criteria, or other conditions that may be attached to a particular scheme. Details of any continuation criteria you need to meet will be detailed in your Scholarship email/ contract, if successful. Decisions will be made at the discretion of CILEX Foundation Trustees or their designated officer.

12. Payment

- 12.1 Scholarships will be paid in equal instalments ahead of each academic period of study. You will be notified in your award email about the payment schedule.
- 12.2 We reserve the right to hold scholarship payments if we are informed that you are not expected to fulfil the CPQ requirements.

13. Changes to study

13.1 If you change your course or mode of study and are in receipt of an award which is for example course/mode specific, it may be withdrawn. If you make a change to your original course of study you must notify the Charity Support Officer as it may affect your continued eligibility.

14. Suspensions and withdrawal from studies

- 14.1 If you suspend or withdraw from your studies then you will not be eligible to receive any future award payments in that year. Please notify the Charity Support Officer of your change in circumstances for support and advice, as it may affect your continued eligibility.
- 14.2 You may be eligible to receive any outstanding awards due upon your return to studies, following a period of suspension.

15. Repeating or deferring your studies

- 15.1 Scholarship awards will not be paid during any repeat period(s) of study. This includes studying for the same academic year twice even if this is for a different course.
- 15.2 If you defer or withdraw and restart, any award already offered may become void. If eligible, you will be considered for support the following year.
- 15.3 The CILEX Foundation cannot fund resits in the event that a student has failed an exam. Any additional costs associated with resitting a module will be the responsibility of the student.

16. Disciplinary action and fraudulent applications

16.1 The CILEX Foundation reserves the right to withdraw an award from anyone who is found to have misled the CILEX Foundation about any aspect of their eligibility and to seek repayment of any monies already paid to them. In such cases the CILEX Foundation may seek to recover any money paid as a debt in the county court (in which case it may also seek to recover additional sums such as interest, court fees and legal costs). We may request at any point, for audit purposes, evidence of any widening participation criteria as stated in your application.

16.2 The CILEX Foundation reserve the right to notify regulators and other legal or law enforcement authorities if an application is found to be fraudulent.

17. Appeals

17.1 The CILEX Foundation's decision on the interpretation of eligibility criteria is final and there is no right of appeal. You may make a complaint if you believe that you have not been considered for an award because of a procedural error, or you believe that there has been some other procedural problem with our allocating and awarding system. Complaints should be made under the terms of the CILEX Complaints Policy. You must comply with all requests for additional information to establish your eligibility within the timeframes specified and you must submit any evidence requested by the stated deadlines.
