# What is a Chartered CILEX Paralegal?

A Chartered Paralegal is a legal professional who has achieved a recognised level of work-based experience, legal knowledge and technical expertise within their field.

We've worked with employers to determine clear standards for Chartered Paralegals. They are both regulated and visible on a public register, providing reassurance on their level of expertise and quality of service for both your organisation and your clients.

## **Application process and costs**

The CILEX Experience Assessment (CEA) is a route to applying for Chartered Paralegal status, offering an alternative approach to traditional CILEX qualifications and exams. CEA assesses evidence which is submitted to demonstrate professional competence gained through work experience.

- 1. Employee completes the application form: The application asks the employee to demonstrate they have met the professional experience requirements through a series of questions linked to the duties and behaviours expected of a legal professional working at this level.
- **2. Employer validates professional experience submission:** A referee or supervisor is asked to declare the information provided by the employee is accurate.
- **3. Interview with CILEX assessor:** An interview will take place with the applicant to ensure a comprehensive understanding of the activities and behaviours evidenced in the application, and to confirm that the required competence level has been met.

## Who can become a Chartered Paralegal?

A professional who has been working in a legal role for over 5 years and is able to demonstrate extensive legal knowledge and competence across key duties and behaviours.

If you have members of your team who don't yet have this level of experience, you can recognise them through CILEX Paralegal status, providing they have a minimum of 2 years of experience in a legal role.
