Introduction

The **CILEx Level 3 Awards/Certificate/Diploma for Legal Secretaries** are Vocationally Related Qualifications (VRQs). They have been developed as part of a range of Level 3 qualifications aimed at those interested in a career in a legal or business environment. They are accredited as part of the Regulated Qualifications Framework (RQF). The emphasis is on 'learning by doing' and learners are required to complete a number of assessments which will show their application of knowledge in a practical context.

The qualification suite comprises of 17 units. To achieve any one of the Level 3 qualifications learners must successfully complete the assessments for all specified mandatory and optional units.

Who are the qualifications for?

The **CILEx Level 3 Awards for Legal Secretaries** is aimed at learners currently employed or seeking employment in an area in which a basic knowledge of law and office administration skills will feature in or underpin their work.

The **CILEx Level 3 Certificate for Legal Secretaries** will be of interest to those already at work in the legal environment in a 'paralegal' capacity or those who wish to go on to qualify as Chartered Legal Executives.

The **CILEx Level 3 Diploma for Legal Secretaries** provides the opportunity for learners to develop a broader understanding of the different areas of law and office skills to enable them to progress their legal career, in particular, those who wish to become paralegals and Chartered Legal Executives.

What do the qualifications cover?

The **CILEx Level 3 Awards in Legal Secretaries** – covers basic skills and knowledge required for working as a legal secretary.

CILEx Level 3 Certificate in Legal Secretaries covers the general range of areas related to the skills and knowledge required for working as a legal secretary.

CILEx Level 3 Diploma for Legal Secretaries covers a wide range of areas related to the skills and knowledge required for working as a legal assistant. The Diploma allows the learner to commit more time to studying a wider variety of units to support their learning than is possible with the Level 3 Certificate.

What progression opportunities are there?

Awards – Learners can progress to

- CILEx Level 3 Certificate for Legal Secretaries

Certificate - Learners can progress to:

- CILEx Level 3 Diploma for Legal Secretaries
- Level 3 Certificate in Law and Practice (CILEx)
- A Paralegal Apprenticeship (Level 3)

Diploma – Learners can progress to:

- Level 3 Certificate in Law and Practice (CILEx)
- A Paralegal Apprenticeship (Level 3)

These qualifications may lead to employment as a paralegal or legal assistant.

What are the entry requirements?

There are no entry requirements for these qualifications. However, centres must ensure that learners have the potential and opportunity to achieve the qualifications.

Learners wishing to register for these qualifications must be 16 or over as these qualifications are not approved for under 16s, with the exception of:

- Level 3 Diploma for Legal Secretaries.

Recognition of Prior Learning

Recognition of prior learning **cannot** be given for these qualifications.

What do you need to do to achieve the qualifications?

Awards

To achieve either of the **CILEx Level 3 Awards for Legal Secretaries**, learners must achieve the mandatory units listed and any required optional units. Credit totals vary depending on the Award.

Certificate

To achieve the **CILEx Level 3 Certificate for Legal Secretaries**, learners must achieve the **four** mandatory units (**33 credits in total**).

Diploma

To achieve the **CILEx Level 3 Diploma for Legal Secretaries**, learners must achieve the **four** mandatory units (**33 credits**) and either of the following options:

- at least a further **6 credits** from the optional units (**39 credits in total**).

- **5 credits** from the mandatory Legal Studies unit and at least a further **4 credits** from the optional Legal Studies units listed

How long will it take to achieve the qualification?

A guide to the time needed to achieve each of the qualifications is shown below.

Total Qualification Time (TQT) is the total amount of time, in hours, expected to be spent by a Learner to achieve a qualification. It includes both guided learning hours (**GLH**) and hours spent by the learner in preparation, study and assessment.

Centre requirements

Approval

To offer these qualifications, new centres will need to gain both centre and qualification approval. Please refer to the CILEx Accreditation Handbook for further information.

Centre staff should familiarise themselves with the structure, content and assessment requirements of the qualifications before designing a course programme.

Resource requirements

Centre staffing

Staff delivering these qualifications must be able to demonstrate that they meet the following occupational expertise requirements. They should:

- have a recognised qualification in law at or above the level they are teaching;
- be occupationally competent or technically knowledgeable in the areas for which they are delivering training. This knowledge must be to at least the same level as the training being delivered;
- have recent relevant experience in the specific area(s) they will be assessing;
- have credible experience of providing training.

Centre staff may undertake more than one role, e.g. tutor and assessor or internal quality assurer, but cannot internally verify their own assessments.

Assessors and Internal Quality Assurers

Assessor/Internal Quality Assurer TAQA qualifications are valued as qualifications for centre staff, but they are not currently a requirement for the qualifications.

Continuing professional development (CPD)

Centres must support their staff to ensure that they have current knowledge of the occupational area, that delivery, mentoring, training, assessment and verification is in line with best practice, and that it takes account of any national or legislative developments.

Delivering the qualification

Initial assessment and induction

An initial assessment of each learner should be made before the start of their programme to identify:

- if the learner has any specific training needs,
- support and guidance they may need when working towards their qualifications.
- any units they have already completed, or credit they have accumulated which is relevant to the qualifications.
- the appropriate type and level of qualification.

We recommend that centres provide an induction programme to ensure that the learner fully understands the requirements of the qualifications, their responsibilities as a learner, and the responsibilities of the centre. This information can be recorded on a learning contract.

All approved centres will be provided with a myCILEx account. This will be the portal for receiving all information from CILEx including:

- Qualification Handbooks
- Assignments to be used for assessing learners
- Guidance on conducting assessments for both the multiple-choice test (Surpass Guide), the Dated Entry Assessments and the Assignments
- Forms for registering learners and claiming certificates
- CILEx policies and procedures

The key contact at the centre will be given a log-in and password which will allow access to the myCILEx portal. Centres are reminded that they must ensure there are contingency arrangements if the key contact person is absent for any reason and access to any of the documentation is needed.

Using Surpass

Multiple choice tests are delivered using the online Surpass system. Centres will need to ensure that they have tested the Surpass SecureClient (by using a mock test provided by CILEx) successfully at their centre. The key contact at the centre will then be given the log-in to the live Surpass system and the password which will allow access to the to the invigilation area of the Surpass system.

Delivering the Assessments

Multiple Choice Test – For details of how to deliver Unit 201 The Legal Environment multiple choice test Assessors should refer to:

- Learners Guide to Using Surpass (Appendix 4)

- Guidance for Tutors on Setting up and Delivering The Legal Environment Multiple Choice Test (Appendix 3)

Assignments – Learners must successfully complete **one** assignment for each of the units assessed by assignment, apart from unit 320/321 Legal Text and Audio Processing for which **two** assignments must be successfully completed. For details of how to deliver the internally marked assignments Assessors should refer to the Guidance for Assessors (Appendix 1). Assignments that are marked by the centre tutor/assessor and will be subject to verification by CILEx to ensure that delivery and marking are conducted properly and fairly.

Assignments should take no longer than 3 to 5 hours. If they do, centres should consider why this is, and make sure that learners are not trying to gather too much evidence.

Dated Entry - examinations are externally set, externally marked assessments. Unit 323 (Proofreading in the Legal Environment) and unit 327 (Legal Terminology) are dated entry assessments. Further information can be found in Appendix 16 (Proofreading) and Appendix 17 (Legal Terminology).

Re-sits

Learners may re-sit the assessments as many times as the centre thinks is acceptable within the learner's period of registration.

Registering Learners

Learners must be registered at the start of the programme. Centres should register learners for the Legal Secretaries qualifications using the Learner Registration Form and use the Unit Entry Form to select the units at the beginning of the programme.

For unit 201 'The Legal Environment', unit 323 'Proofreading in the Legal Environment' and unit 327 'Legal Terminology' centres must submit an Examination Entry Form for learners using the Unit Entry Form.

The forms are available through the CILEx website and myCILEx. Centres should email Learner Registration Forms, Unit Entry Forms and Examination Entry Forms to legalsecretaries@cilex.org.uk

Direct Claims Status

Direct Claims Status is issued to those centres who have met quality assurance criteria for carrying out assessments and marking assignments consistently over a period of time. Centres with Direct Claims Status can be issued with learner certificates without prior moderation of marked assignments. Centres who do **not** have Direct Claims Status are required to notify CILEx of learner results. CILEx will moderate results prior to certificates being issued.

Claiming Certificates

Unit claims - Centres will be required to claim unit credit for learners using the Unit Claim Form.

Qualification certification claims - Full qualification certificates are only issued to learners who have met the full requirements of the qualification(s). Centres will be required to claim qualification certificates for learners using the Certificate Claim Form.

CILEx Policies and Procedures

Access Arrangements and Reasonable Adjustments

Access arrangements are agreed before an assessment for learners with temporary injuries or illnesses or other indispositions which present a barrier to accessing the assessments. Reasonable adjustments are adjustments that are made to alleviate or remove the effect of a disability or difficulty that places the learner at a substantial disadvantage when taking an assessment.

Centres are required to keep records of any access arrangements or reasonable adjustments approved. Information that must be recorded includes:

- Learner name and ID number
- Qualification title (including level) and unit title for which the access arrangements/reasonable adjustment is requested
- Details of the access arrangements/reasonable adjustments requested and the evidence supporting the request (supporting evidence must be retained as part of the record)
- Assessment date for which the access arrangements/reasonable adjustments is requested
- Access arrangements/reasonable adjustments approved
- Name and status of the person within the centre approving the access arrangements/reasonable adjustments
- Date the access arrangements/reasonable adjustments were approved.

Access arrangements/reasonable adjustments records must be retained by the accredited centre for 3 years.

Appendix 1 - Guidance for Assessors (Assignments)

General Guidance

This guidance should be read in conjunction with specific guidance in each assignment.

Assessors are strongly advised to check and familiarise themselves with the requirements and feasibility of each assignment before it is issued to learners.

As a minimum Tutors should deliver the full breadth of the units and not limit teaching to the assessment tasks contained in this assessment pack. Lesson plans and learner work, may be sampled by CILEx to evidence the full delivery of the units.

The assignments are set by CILEx and are administered by the centre when the learner is ready.

Assessments can be completed in any order. Centres will be expected to organise the assessments in a logical order according to the requirements of the learners and the course (eg. with regard to work experience placements, visits, etc).

A submission schedule should be worked out by the centre, governed by the overall assessment plan for the course, to be negotiated between tutor/assessor and learner. The relationship between course delivery, the handing out of assignments, and the deadlines for their return are matters for agreement between the tutors and the learners locally.

Each assignment will provide opportunities for learners to be assessed on a sample range of the content required for the unit as specified in the Legal Secretaries Qualification Handbook. Assignments consist of several tasks.

Each assignment contains:

- assessor instructions
- learner instructions
- marking and grading criteria

Each assignment will detail the equipment and resources required to complete the particular assignment. Please note for Legal Text and Audio Processing assignment, centres will require access to Audio facilities. Audio files are provided by CILEx on **MP3 and WAV formats**.

Introducing the tasks to learners

The assessor should introduce each task, making sure that the learners understand what is required of them. It will be beneficial to take the learners through what is required and the way in which each task will be graded as learners need to know what is expected of them to get each grade.

Completion of assignments

Assessors will decide when each learner should complete an assignment and will be expected to organise the assignments according to the requirements of the learners and the course. Tasks should be completed under supervision. An example witness statement form (Appendix 8) should be used to testify that learners who are on distance learning programmes/employer based have completed the assignment in the time recommended.

Assessors are required to administer and mark assignments to the criteria set. Centre staff should guide learners to ensure excessive evidence gathering is avoided. Marking criteria should **not** be shown to learners until grading is complete. The marking criteria should **not** be given to learners under any circumstances.

Learners can expect a reasonable amount of guidance on how to organise themselves in order to:

- accomplish tasks
- check that the evidence of the required underpinning knowledge has been produced.

A learner may be given clarification if they are having trouble understanding what they are being asked to do in the assessment, but they must carry out the task themselves. Learners should be made aware that if they refer to their tutors for guidance on understanding the task, the amount of guidance and support they are given may be reflected in their grade – where this is the case it will be reflected in the grading criteria, all pass criteria need to be based on the learner's own work and therefore met without support.

Appendix 11 is an example of a document that assessors may use to record the assignments the learner has completed. This is an example only and you may wish to alter it to suit your existing documentation. It can also be used as a tracking document regarding internal verification/quality assurance checking. The IV/QAC can initial and date next to those learners he/she has sampled in red.

You may also consider developing a similar document to track all units on one form. Whatever method you use to ensure quality checks are taking place, please send a copy of your proposed system to CILEx.

Time allowance for assignments

The assignments do not need to be taken under timed, controlled conditions, however, it is anticipated that the assignment should take learners no longer than 3 to 5 hours (excluding research time), to complete.

The following assignments will need to be taken under timed, controlled exam conditions and should **not** be shown to candidates prior to the assessment session:

- Legal Text Processing (Unit 320)
- Legal Audio Processing (Unit 321)
- Legal Spreadsheet Processing (Unit 324)
- Legal Database Processing (Unit 325)
- Legal Presentation Techniques (Unit 326)

Legal Text Processing assignments for unit 320 have been allocated time allowances for each assignment, and form part of the marking criteria. Working/Business Skills in the Legal Environment assignments are expected to take **5 hours** (Unit 322).

Centres finding that assignments are taking longer, should contact CILEx for guidance.

Knowledge and understanding tasks

A knowledge and understanding task should only be provided to the learners once it is evident that they are ready to undertake the summative assessment. A realistic timeframe should be set for completion of the task.

Learners should be able to negotiate deadlines where they have a good reason for the request, but reliability and punctuality are watchwords of employment and centres will refer to their own centre policy when dealing with late submissions where no good reason is provided.

The tasks learners have been set for this qualification should not prevent access unfairly. If a task is thought to prevent unfair access due to the type of evidence required, advice should be sought from CILEx on providing the evidence in a different format. For example, if a task requires the learner to provide information as a poster, then unless the design of the poster is being assessed, an alternative format such as an information sheet or report may be acceptable. Note however, that the requirements of the task must still be met in full and the marking/grading criteria applied without change.

In some cases, these can be completed away from the centre in the learners' own time. This is only appropriate when:

- original thought on the part of the learner is required, and marking criteria require demonstration of understanding, interpretation or evaluation of information. Here it can be expected that each learner's evidence will be in their own words, and therefore identifiable as their own work, ie **not** straight recall of facts.
- where the assessor is confident that they will be able to accurately authenticate the learners' evidence as their own, and detect any plagiarism.

Methods to support authentication of learner work may include:

- final write-ups to take place under controlled or test conditions (**always** required where the evidence is straight recall of facts)

For evidence produced outside controlled conditions:

- requiring learners to sign a declaration that the work is their own
- requiring the learners to reference all sources
- supplementary (oral) questioning to gauge familiarity with the topic
- looking out for any changes to the learners usual writing style, unusual sources/examples or the use of eg US spellings or phrases that might indicate cutting and pasting from the internet.
- requiring access to evidence of steps in the process eg drafts, notes, planning etc

For further information on authenticating learner work, see: www.ofqual.gov.uk/plagiarism-teachers

Marking and Grading

The assignments are marked and/or graded internally, using the to the criteria set and the outcomes recorded on the documents provided by CILEx (see Appendix 11). Each assignment is graded as either Re-sit, Refer, Pass, Merit, Distinction in accordance with the grading criteria for the assignment. In general, a Pass is 50%, Merit is 65% and Distinction is 80%, although this may vary slightly depending on the assignment.

Specific marking and grading criteria is provided in each Working/Business Skills in the Legal Environment assignment. Generic marking and grading criteria is provided for Legal Text and Audio Processing assignments in Appendices 12 and 13. Generic marking and grading criteria is provided for Legal Information processing assignments in Appendices 14 and 15.

For Level 3 Award in Legal Information Processing, the assessment is graded re-sit, refer, pass, merit or distinction. The overall certificate will not show the grade, candidates will receive a Certificate of Unit Credit (CUC) detailing the grade.

These grades are then combined according to the rules for combining unit grades in Appendix 6 to give an overall grade for the qualification being claimed where applicable.

Assessments are subject to internal and external verification. Evidence generated should be available to EQA for scrutiny, as per the normal visit or when requested. You may also consider developing a similar document to track all units on one form. Whatever method you use to ensure quality checks are taking place, please send a copy of your proposed system to your EQA.

Feedback

A feedback sheet has been provided in Appendix 9. Although some feedback may be given verbally, this is often forgotten by the learner after the assessment, and so, assessors should complete the feedback sheet for each learner, showing the key information given to the learner. This will also serve as an action plan for learners who are unsuccessful in a task and need to do further work before taking the task again.

Re-sits and Retakes

Retakes

The tasks are summative assessments and, other than to gain a Pass, learners may not retake tasks to improve grades. It is therefore essential that the tasks are not used for formative purposes and the learners only attempt them when they are judged to be fully ready. If a learner fails only one task within an assignment they may retake the whole task, however they will only be able to achieve a Pass overall for the whole assignment.

It is at the centre's discretion whether to allow a learner to retake a task, unless otherwise specified. A reasonable time should be allocated by the assessor for a learner to repeat a task; this must be indicated on the assessment record. A learner should not be allowed to retake until it is evident that they are ready to undertake the task.

Learners can reuse any research that they have previously carried out and supplement their evidence when retaking a task.

Re-sits

If a learner fails more than one task they **must** take a re-sit assignment – an alternative version. It is at the centre's discretion as to whether they allow a learner to take more than one re-sit assignment, taking into account the individual's circumstances, centre resources, time available etc.

Assessors should ensure that the learner receives appropriate support before the learner is allowed to re-sit the assignment. It is recommended that assessors should allow a minimum of seven days or alternative sufficient period of time.

Should tutors/assessors wish to prepare learners for the assessments, they may use the sample assignment available on the [CILEx website](#) and/or devise their own material internally and provide feedback on these.

Recognition of Prior Learning (RPL)

Recognition of prior learning means using a person's previous experience or qualifications which have already been achieved to contribute to a new qualification. RPL is **not** allowed for these qualifications.

Health and safety / Codes of practice

The importance of safe working practices, the demands of the Health and Safety at Work Act and the Codes of Practice associated with the industry **must** always be adhered to.

The requirement to follow safe working practices is an integral part of all CILEx qualifications and assessments, and it is the responsibility of centres to ensure that all relevant health and safety

requirements are in place before learners start practical assessments.

Learners have responsibilities for the safety of others as well as themselves. Anyone behaving in an unsafe manner must be stopped and suitable warnings given. A learner should not be allowed to continue working on an assignment if they have contravened these requirements.

Verification of assessments

Centres must use the provided documentation, unless otherwise agreed, to ensure that CILEx can check that evidence for an assessment is complete and ensure that the assessment decision is fair and beyond dispute. Centres may devise additional documentation/forms to support those provided by CILEx.

If a learner's work is selected for verification, samples of work must be made available to CILEx who will check that:

- the quality assurance co-ordinator is undertaking his/her responsibilities
- the quality assurance co-ordinator is given prompt, accurate and constructive feedback on centre operations
- CILEx is provided with a written report on centre activities.

CILEx will visit the centre/learning provider to:

- ensure that quality assurance co-ordinators are undertaking their duties satisfactorily
- monitor internal quality assurance systems and sampling assessment activities, methods and records
- act as a source of advice and support
- promote best practice
- provide prompt, accurate and constructive feedback to all relevant parties on the operation of centre's/learning provider's assessment systems.

Data protection, security

The centre should have available a copy of the Data Protection Act and bring its contents to the attention of learners.

Centres should themselves ensure that all evidence produced by learners is kept secure and that assignments are kept locked safely away until their use. It is the responsibility of the centre/assessor to be sure of a learner's identity before allowing the learner to take the assessment

Retention of evidence

In order to fully support learners and to be compliant with the verification process, centres are

required to retain learners' evidence and learner assessment **records** (see the CILEx Accreditation Handbook for details) must be retained for **three years** after certification.

Types of evidence

Assignments are written in a way to encourage learners to produce different types of evidence eg briefing notes, letters, and memos.

It is important that learners ensure their name and enrolment number is on all items of evidence handed in.

Authenticity

Centres are reminded to check for authenticity of work where learners may be using texts and the internet to complete tasks.

Quality assurance of assignments

These qualifications are Vocationally Related Qualifications (VRQs) and do not imply occupational competence. Centres are required to establish a system of internal verification/scheme co-ordination to monitor assessors' decisions. This means that the work of assessors involved in the qualification(s) must be monitored by a quality assurance co-ordinator, to ensure that assessors are applying the standards consistently throughout assessment activities. Quality assurance co-ordinators/programme co-ordinators and CILEx will sample learners' work to ascertain whether the evidence for an assignment is complete, and to ensure that the allocation of grades by assessors has been fair and beyond dispute. It is for this reason that the signature of both the assessor and the learner is required on the assignment mark sheet.

Assessors must ensure that learners understand why a particular assessment decision has been reached. Where learners do not feel that the assessment decision has been fair, they should have the opportunity to access the normal appeals/complaints procedure of the centre/learning provider in the first instance, and if this does not resolve the situation, they can refer their appeal to CILEx.

The use of grading for the assessment of practical work makes it possible for verifiers to use a system of sampling, but when doing so they have to be sure that the evidence is complete and that the allocation of marks and grades has been fair and beyond dispute. It is for this reason that both the assessor's signature and that of the learner is required on the final mark sheet. Quality assurance co-ordinators need to be sure learners understand why the relevant grade has been allocated for the qualification.

Learners' work may also be subject to external verification, which may be by a visit or by post. There will normally be one external verification activity per centre, per year.

Guidance on qualifications/experience for trainers/learning providers

All new teachers delivering publicly funded qualifications in the learning and skills sector (all post 16 education – including FE, adult and community learning, work-based learning, offender education) in England are now required to take qualifications which form part of the Qualified Teacher – Learning and Skills (QTLS) framework.

Centre staff may undertake more than one role eg tutor and assessor or internal verifier, but must **never** internally verify their own assessments.

Trainers/tutors must

- be technically competent in the area(s) for which they are delivering training. This knowledge must be above the level of the training being delivered.
- Have credible experience of providing training.

Assessors and internal verifiers

Assessors should have recent relevant experience in the specific area they will be assessing. Assessors need to have a greater level of experience and understanding than those they are assessing.

In addition, assessors must demonstrate the ability to mark assignments using externally set criteria. While the Assessor/Verifier (A/V) units are valued as qualifications for centre staff, they are not currently a requirement for the qualifications.

Continuing professional development (CPD)

Centres are expected to support their staff in ensuring that their knowledge of the occupational area and of best practice in delivery, mentoring, training, assessment and verification remains current, and takes account of any national or legislative developments.

Assessment Materials - Conditions of Use

CILEx Assessment Materials are protected by copyright and are supplied only to Approved Centres for use solely for the purpose of summative assessment.

Appendix 2 - Guidance for Learners

The following are general instructions which should be followed alongside any specific instructions for each assignment.

- Before you start the assignment you should read the assignment text carefully. This will help you to understand how each task fits into the whole assignment.
- You should start each task on a fresh sheet of paper.
- On each sheet of paper you should type or write your name and registration number. Also add an appropriate name to your saved file or as instructed in the task.
- You are expected to check and correct your spelling, grammar and punctuation.
- You may use any books, notes or other material to help you, but you must not copy word-for-word from any source. Under no circumstance must you copy someone else's work.
- You and your assessor must sign each Assessment Record to verify that all the work contained in that assignment is your own.
- When all required assignments and the multiple-choice test have been completed to the required standard you will be awarded the Level 2 Certificate / Diploma for Legal Secretaries (or alternative for Level 2 Awards), whichever is applicable to your centre's programme.



Setting the Scene

Legal Secretaries Certificate/Diploma and Legal Information Processing assignment

The aim of the assignments is to demonstrate the candidate's ability to carry out legal word processing, administration and information processing tasks in a legal setting.

In all the assignments you will be working for the same firm that you have been with throughout your coursework book: **INGRAM LOCHEE & EXTON**, solicitors. As you know, they are a rapidly expanding firm occupying a five-storey office block in the centre of Birmingham. The firm is divided into three main departments: Probate (with a sub-division of Family), Criminal Litigation (sub-division Civil Litigation) and Corporate (sub-division Conveyancing). Each department is in the charge of one of the Partners and is situated on a separate floor. Reprographics, post room, switchboard etc are on the ground floor and interview rooms, staff canteen and rest room on the top floor. As part of the firm's policy, you may be requested to work in any department either on a short-term or a long-term basis.

Students following the Diploma course should be aware that Ingram Lochee & Exton has expanded and has opened new offices in Dartford, Kent. This is a thriving area of the country, close to London, and within the Thames Gateway. The main offices of Ingram Lochee & Exton are still based in Temple Row, Birmingham.

Opening hours

Offices are open 8.00 am - 6.00 pm Monday to Friday. However, staff are contracted to work a 35 hour week with one hour for lunch; most of the administration staff start at 9.00 am.

Holiday entitlement

Holidays run from 1st January - 31st December each year

- Basic entitlement for all secretaries and administration staff is 20 days per year excluding bank holidays.
 - After two years' service, junior secretaries, secretaries and all administration staff receive an extra day and a further day for each additional year up to a maximum of three additional days.
- Senior secretaries receive a maximum of five additional days.
- Solicitors and Chartered Legal Executives start on 25 days and receive a maximum of five additional days.
- Partners receive 35 days.

Valerie Ingram (Probate), Nishad Lochee (Criminal Litigation) and James Exton (Corporate) are the partners. There are 18 solicitors and three FCILEx. (Fellows of the Chartered Institute of Legal

Executives) as shown in the Organisation Chart which you should *study carefully* before you start work on the assignments.

There is a team of 15 secretarial/administrative staff working directly for the 24 fee earners:

- *three senior legal secretaries* who all have the City & Guilds/CILEx Level 3 Diploma for Legal Secretaries and many years' experience. These three are the Partners' secretaries, and so they have varied duties in addition to their legal secretarial role. When time allows, however, they work for any of the solicitors in their department.
- *six legal secretaries* who all have the City & Guilds/CILEx Level 2 Certificate for Legal Secretaries and are working towards the City & Guilds/CILEx Level 3 Diploma for Legal Secretaries on a day-release course at the local college.
- *three junior legal secretaries* who either have, or are about to achieve, the City & Guilds/CILEx Level 2 Certificate for Legal Secretaries, but are less experienced
- *three administrative assistants*, who are taking the City & Guilds/CILEx Level 2 Certificate for Legal Secretaries at evening class.

There are other administrative staff in the Post Room, Photocopying Room, Switchboard, Reception etc.

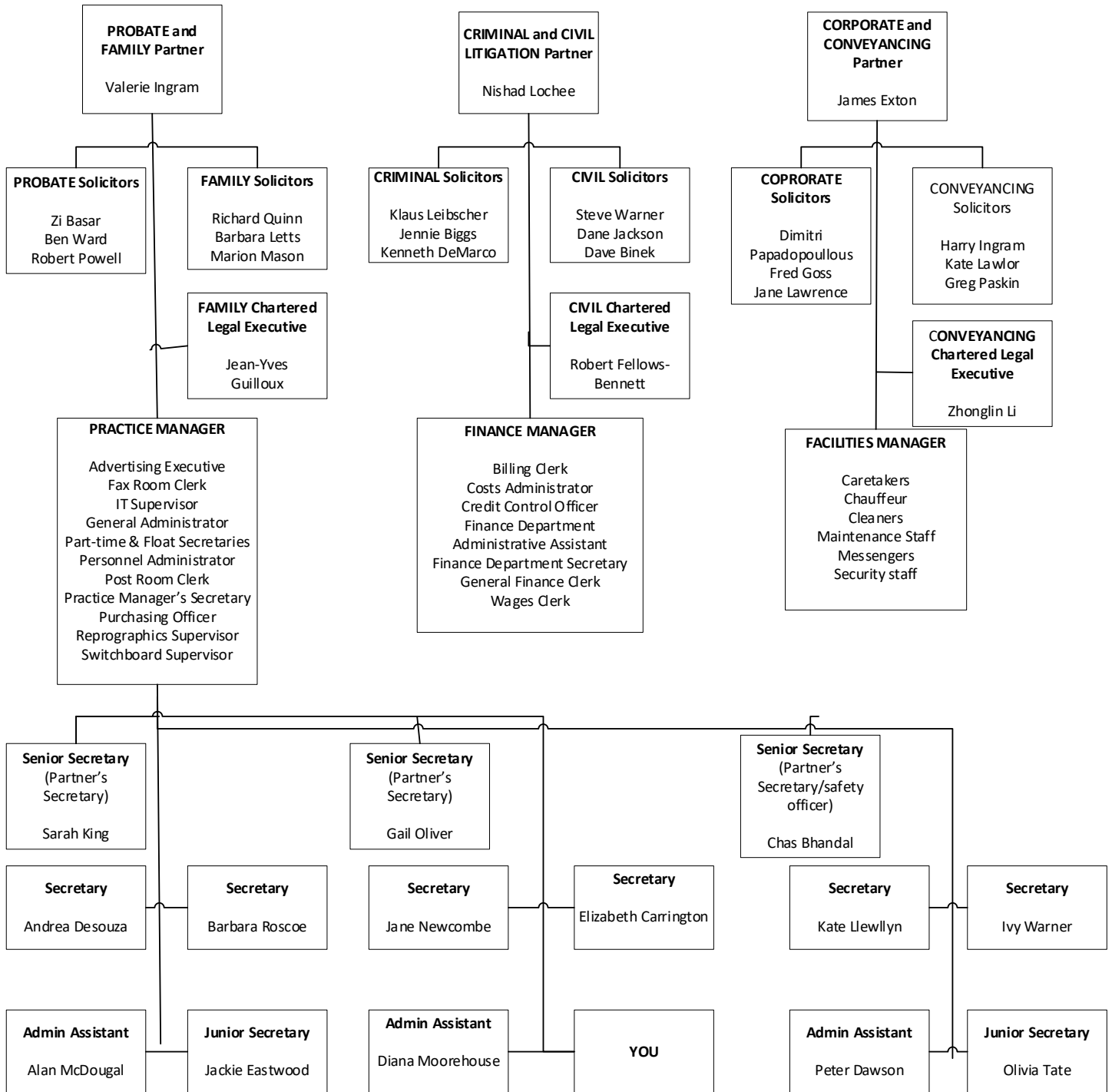

Appendix 3 - Guidance for Tutors on setting up and delivering the Legal Environment Multiple Choice Test

The Multiple Choice Test (MCT) is an externally set and marked multiple choice test that is taken via E-assessment. It is available on-demand. Learners will have 60 minutes to answer 30 Multiple Choice questions.

The following units are assessed by MCT:

- The Legal Environment (Unit 201)

How to run the E-assessment Software.

The MCT will take place on an e-assessment system called Surpass in an locked down environment. You will need to download and install the Surpass SecureClient to run the assessment. This client is specific to CILEx and you will not be able to use any other software to run the MCT assessment. To successfully install and run Surpass, you will need to have equipment equal or higher to the specifications listed below:

- Processor 2.33GHz or faster x86-compatible processor
- Windows 7, 8.1 or 10 (32bit or 64bit)
- Microsoft .NET Framework 4.0
- A stable internet connection
- RAM 1GB
- Adobe Flash Player 18 to 20.0.0.306 *This needs to be the ActiveX version of Flash, i.e. it needs to be installed from Internet Explorer.*
- HDD Space 1GB of free space
- Video Single display
- Screen resolution of 1024x768
- Graphics card with at least 128 MB of memory
- Two button mouse
- Keyboard

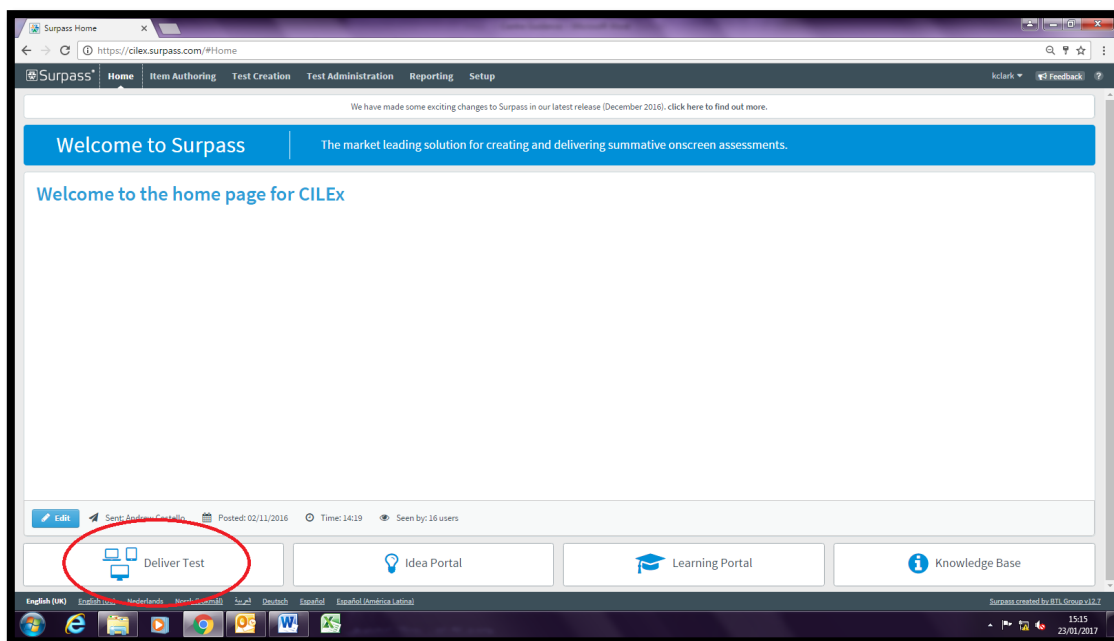
Please note the following limitations:

- *The use of 3G cards may not guarantee a constant bandwidth and could therefore not meet the minimum requirements.*
- A centre connection of 2Mbps or greater for every 30 learner tests being sat at the same time is recommended to ensure learners are not affected by connection issues during test delivery.
- *Surpass SecureClient is not compatible with Multiple Monitor setups.*
- Virtual Environments (such as Citrix) and certain firewalls may cause proxy errors – these will make Surpass un-useable.

Once you have become accredited, you will be provided with a login detail to Surpass. To download the Surpass SecureClient, please follow the link to our [Surpass site](http://www.cilex.surpass.com) (www.cilex.surpass.com) and use your details to log on.



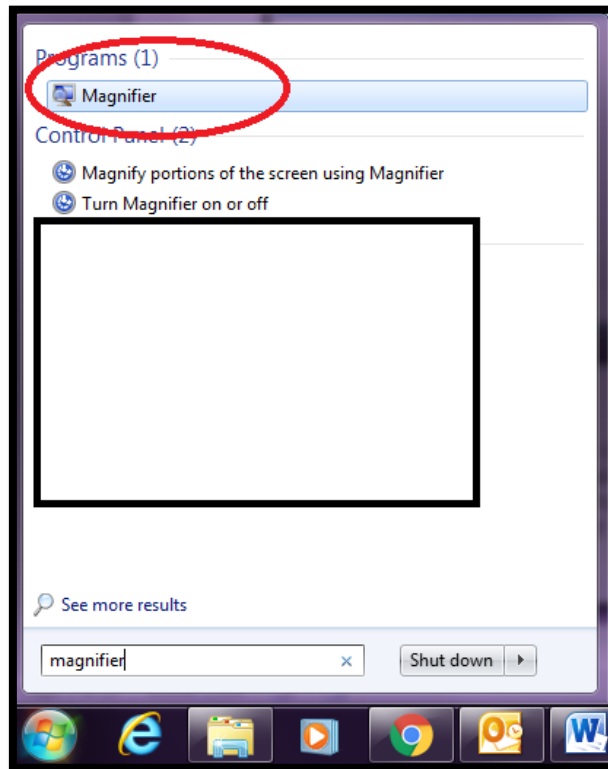
You will then find yourself on the Home Screen for Surpass. In the bottom left-hand corner, you will find a link 'Deliver Test'. This will bring you to where you can check the technical specifications for Surpass and download the SecureClient.



Click 'Secure Delivery' and then click 'Download SecureClient (MS)'. This will start the download and installation of the software. Please follow the onscreen instructions when prompted. You may need to contact your IT department to enable the correct permissions to allow an installation.

Please note that Surpass update the SecureClient software, these updates will need to be applied upon release in order to run the MCT. We will notify all centres when you will need to perform software updates. Failure to perform these updates promptly may cause issues to occur when conducting the live assessments.

Surpass is compatible with the Windows Magnifier software to enlarge the screen. This will need to be set up and running before the SecureClient is booted as SecureClient will lock down the station.



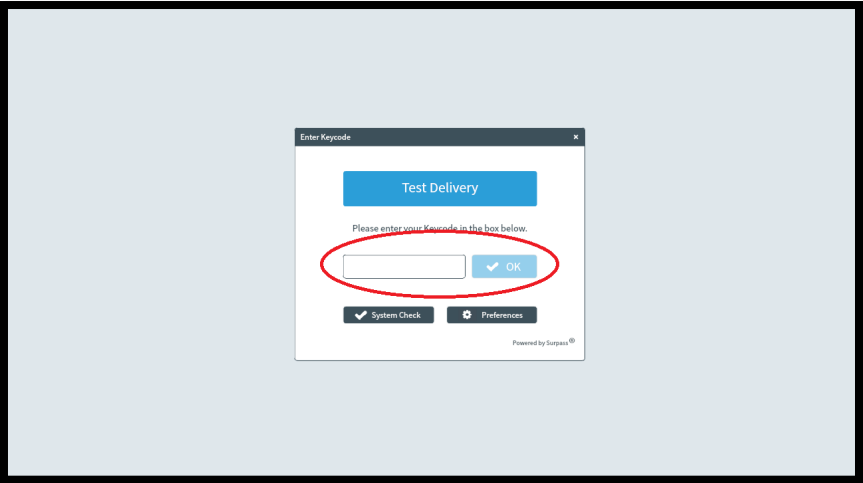
What to expect on the day

Prior to the day of the assessment, you will be sent a set of Learner Keycodes and a centre PIN. This information will need to be ready for distribution to your learners on the day – we recommend printing out individual copies of the Keycodes for each learner.

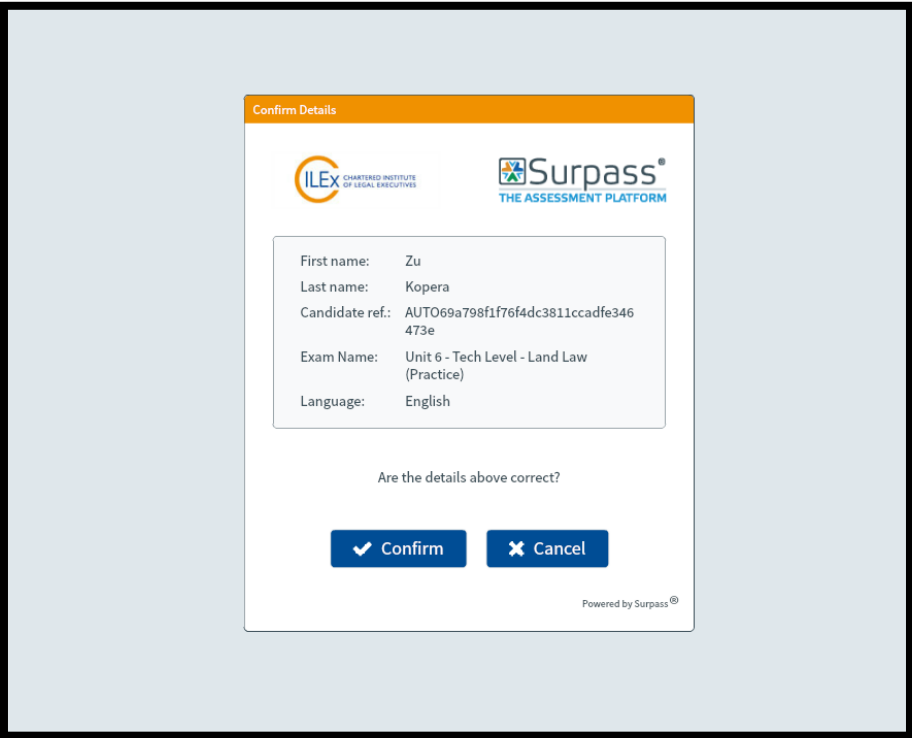
Please note that each Keycode is unique to the named learner and cannot be swapped. The Keycodes are also single use and will not allow you to re-enter them once the MCT has started.

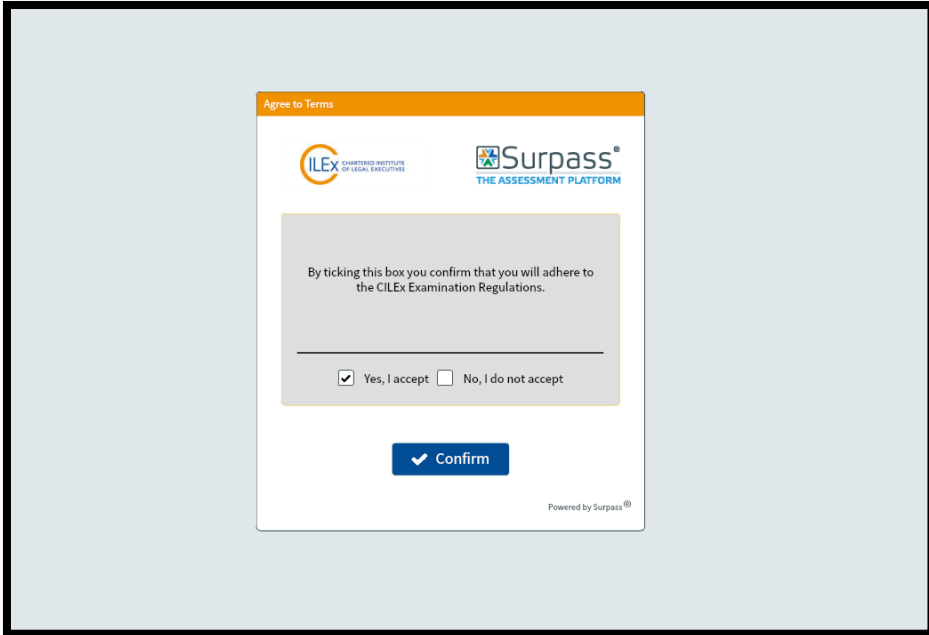

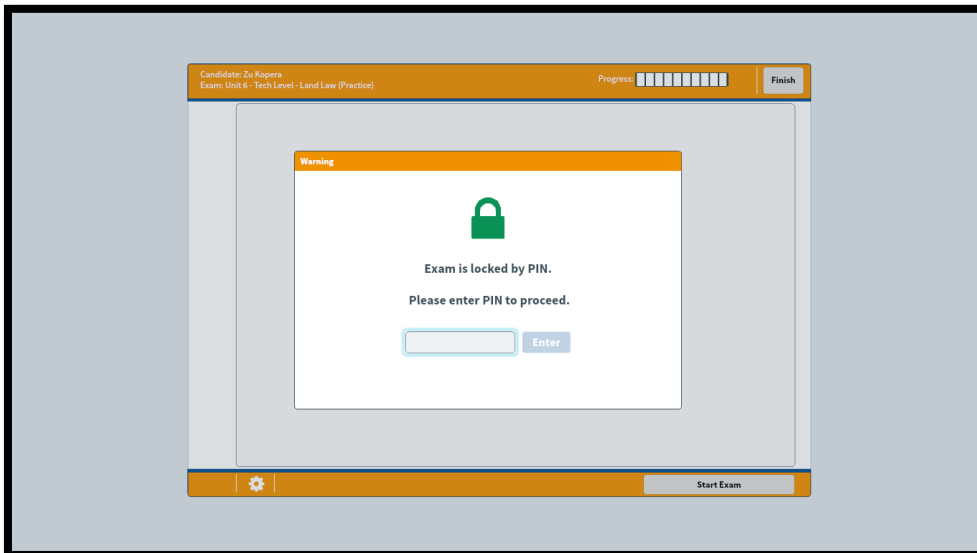

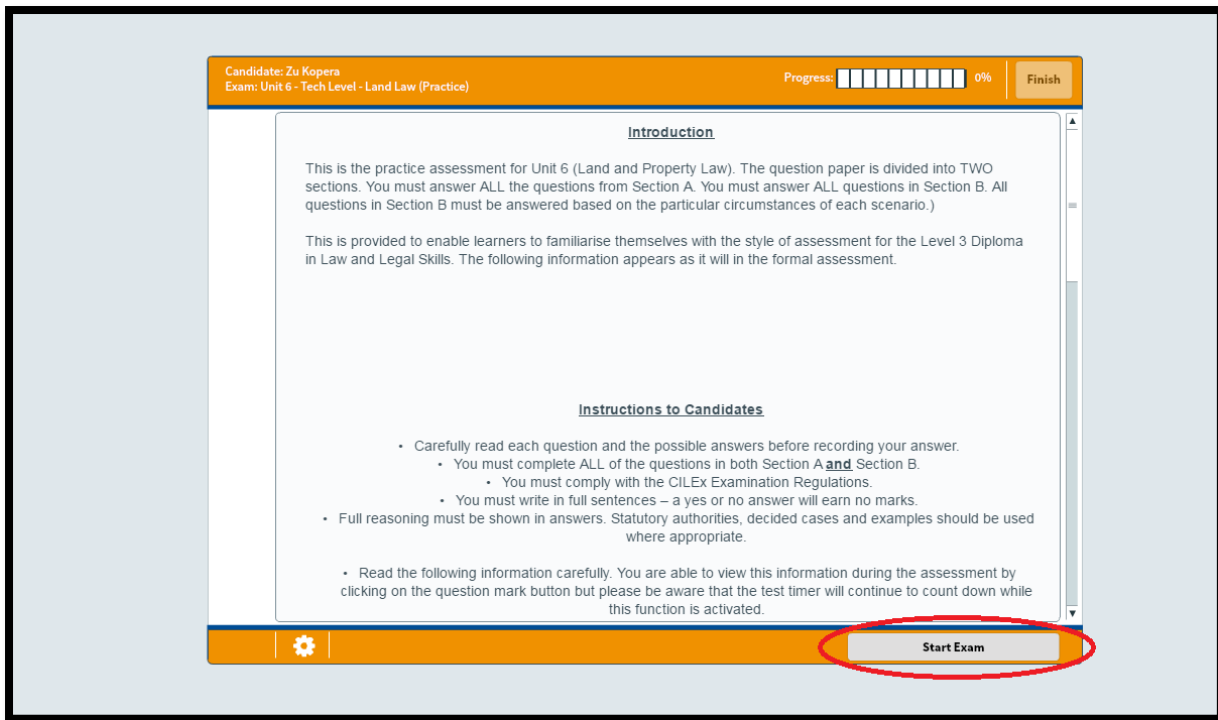

Once the PIN has been entered, the examination will download and the learner will be shown to the Introduction Screen. This page will contain important information; such as length of examination, number of questions required and how to use the tools provided in Surpass.

An over view of the tools available in Surpass can also be found in the Surpass Learner Guidance (Appendix 4).

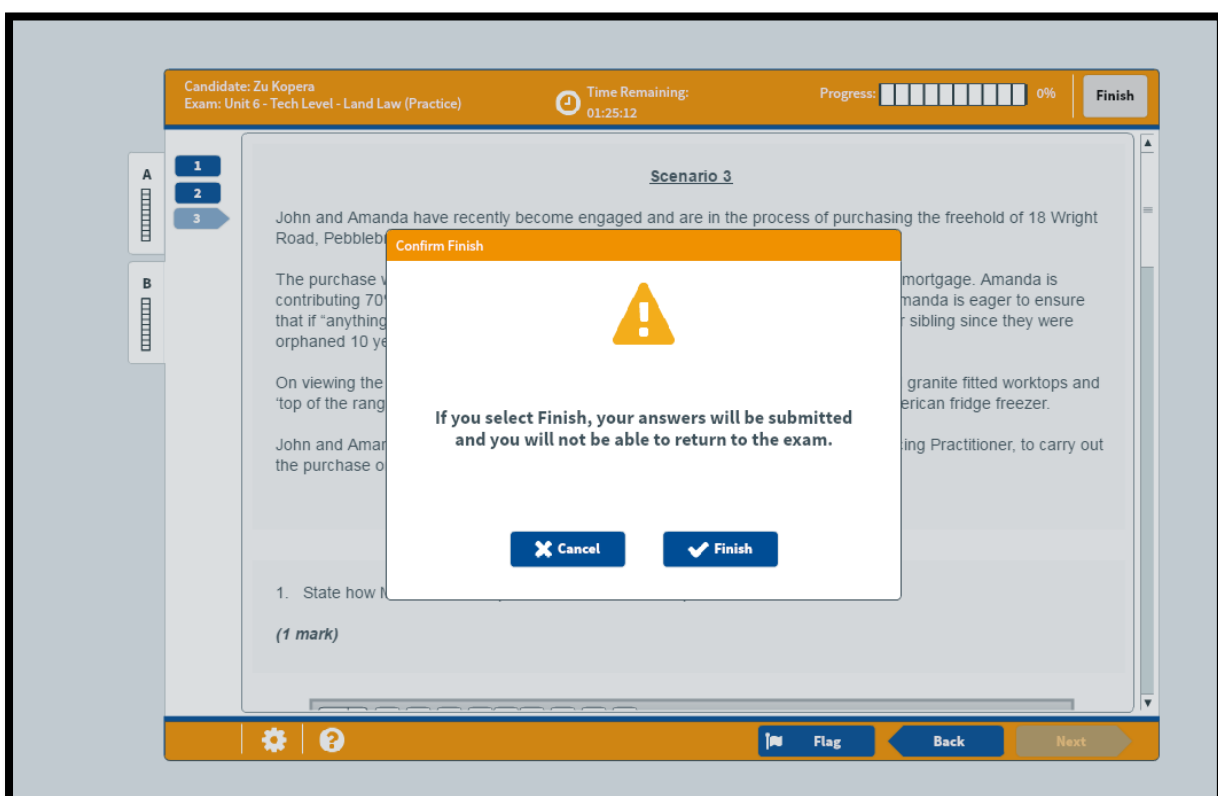
All Learners should be encouraged to thoroughly read the Surpass Learner Guidance prior to the examination.



Once the learner has read the information and clicked to start the 'Start exam' button, the timer will begin to count down.

All learners should be encouraged to read the Introduction and Instructions to Learners carefully. All CILEx Regulations should be followed at all times.

When the learner finishes the examination, they will be prompted to check that they have completed all questions before exiting the examination.



Once they confirm this, the SecureClient will attempt to send their answers to CILEx where they will be stored for marking. This means that a learner cannot then go back and change answers.

They will then need to wait for confirmation by the invigilator before they are allowed to leave. Learners are not allowed to leave an examination during the first 45 minutes or the last 15 minutes (as seen in the CILEx Examination Regulations).

Sample MCT's

Sample MCT's are available upon request for you to test your computer systems and internet speed. Please email legalsecretaries@cilex.org.uk and we can arrange for Keycodes to be sent to you.

How to register for an MCT.

All learners must register for the MCT by the end of the month prior to the exam month. For example, if the learner wishes to sit the MCT in May, they must have registered by the end of March.

Grading

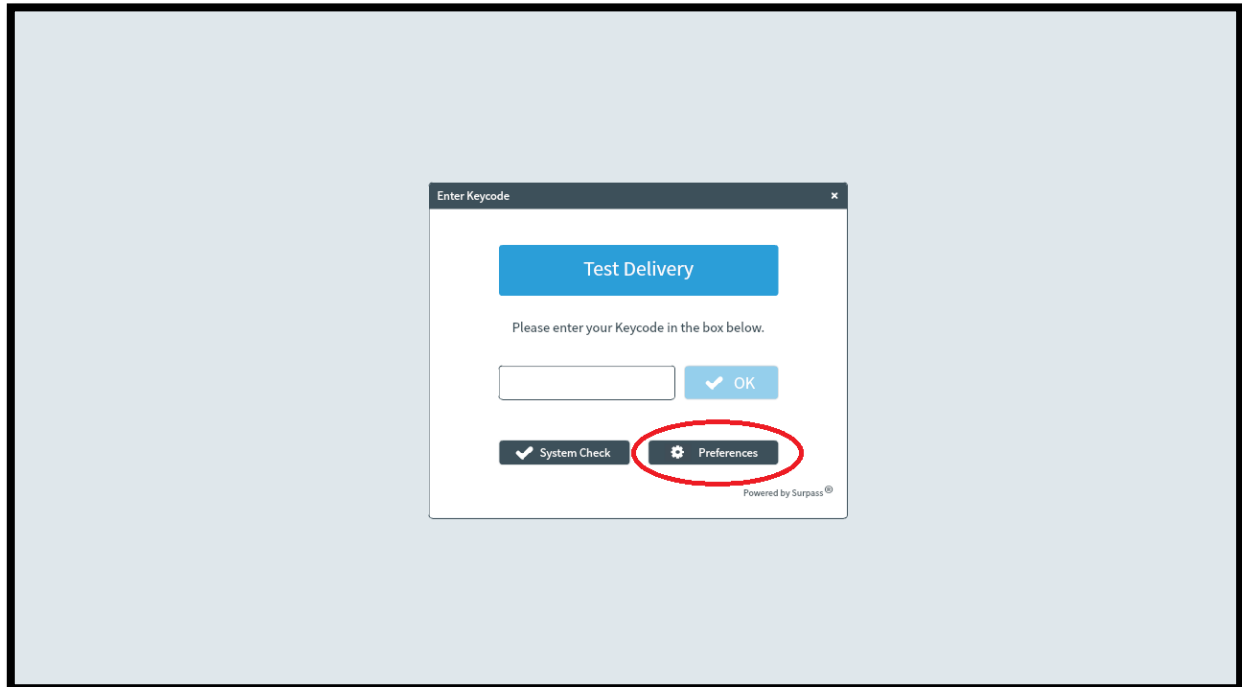

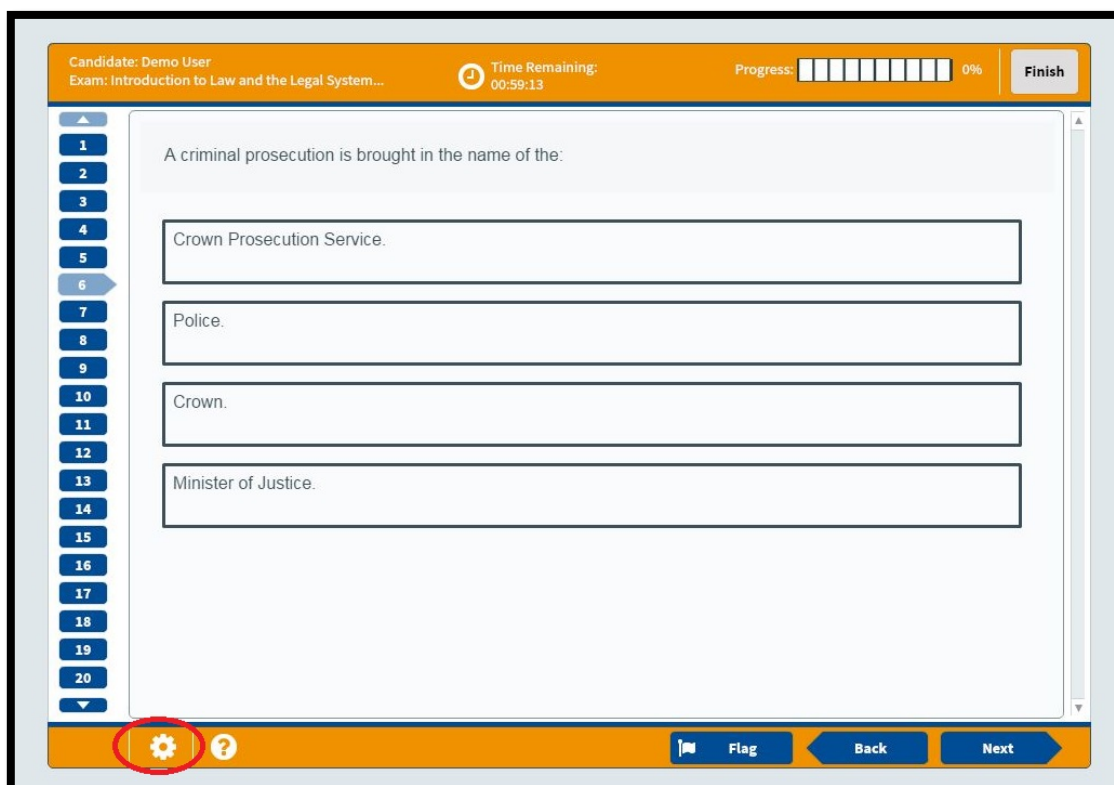

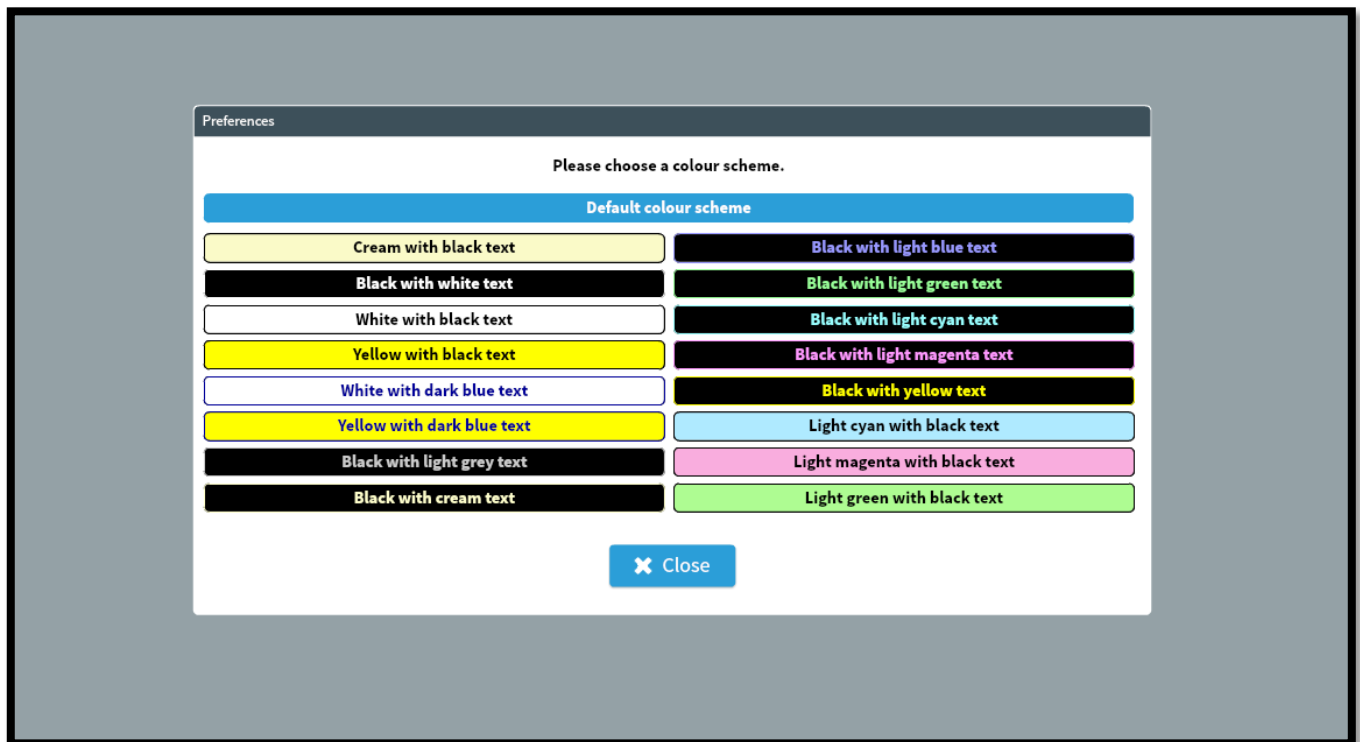

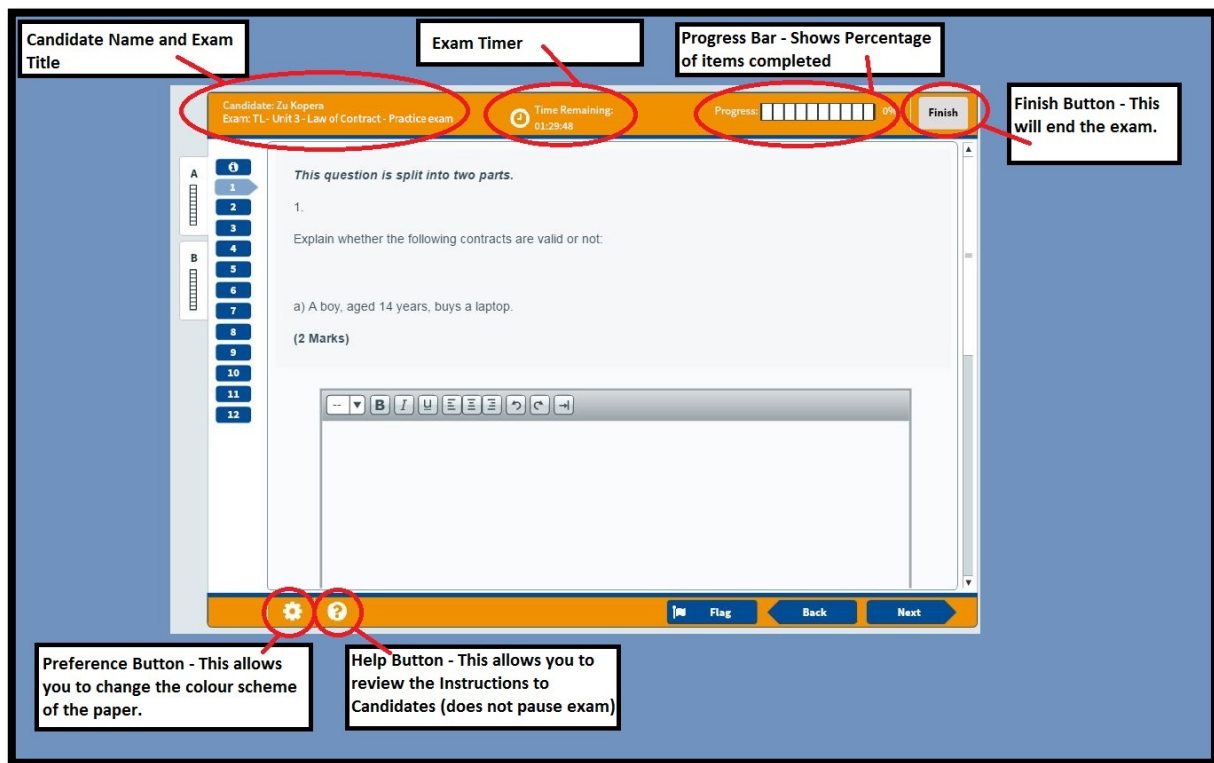

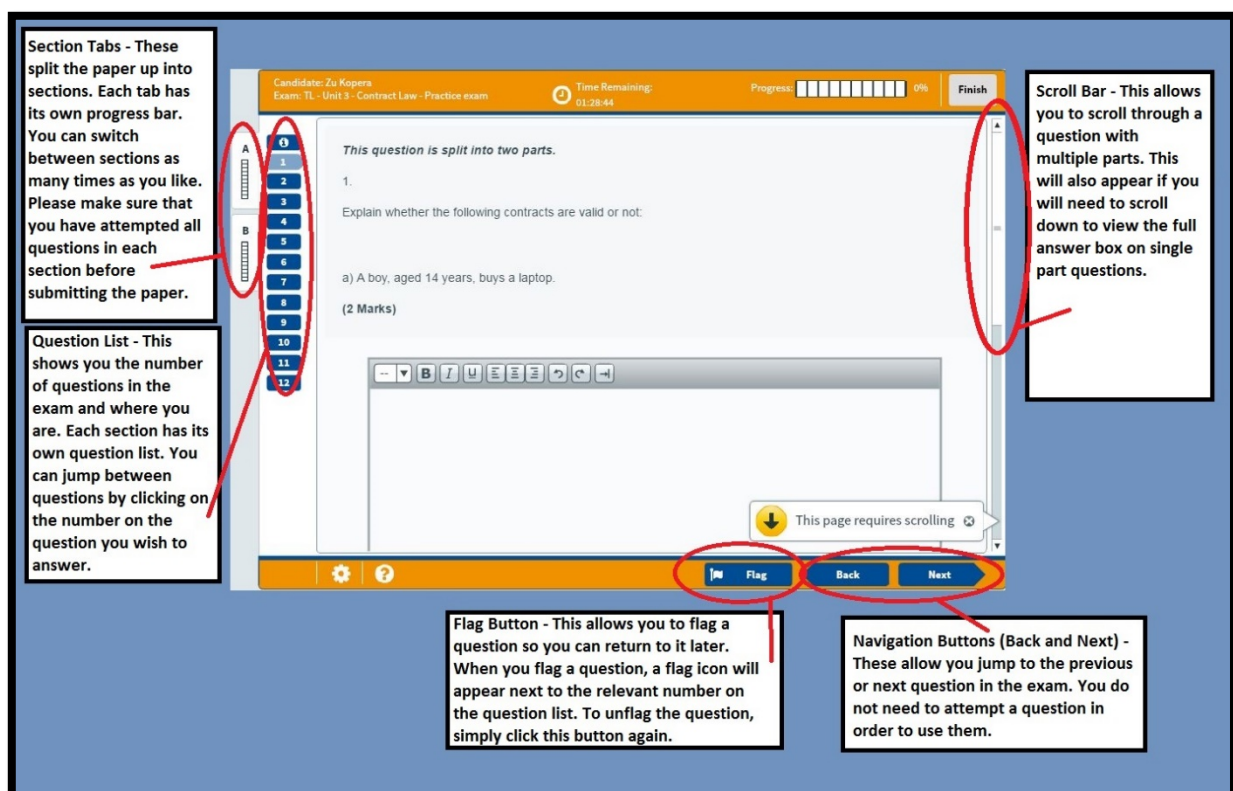


The general layout of the Surpass Exam Screen

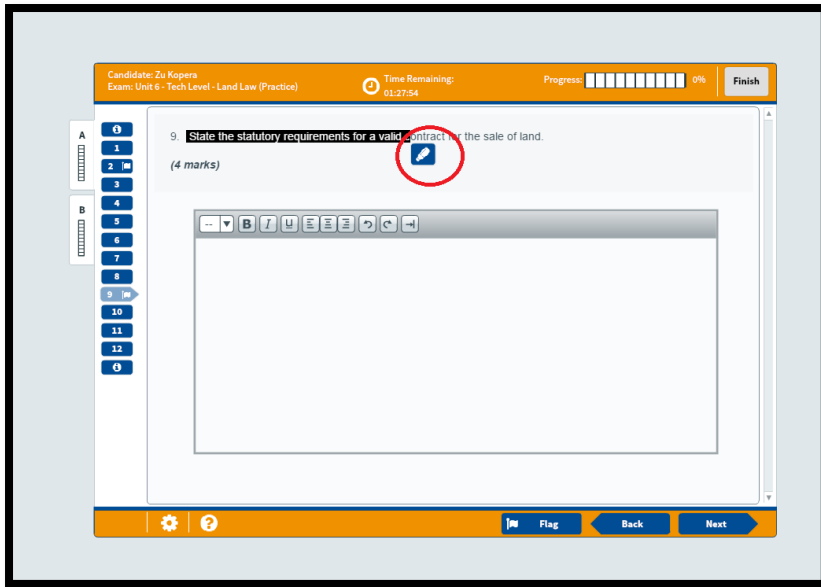

There are several actions and tools available via Surpass that will aid in completing your exam: highlighting text, crossing out answers and flagging questions. These are explained in more detail below.

Highlighting

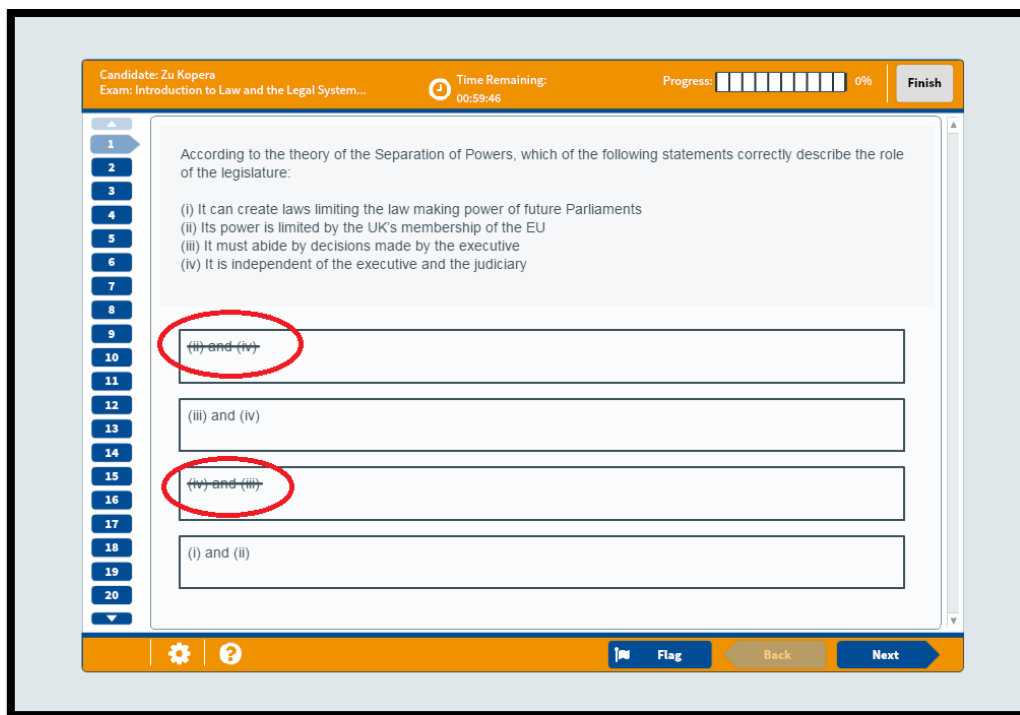
During the test you can use your mouse to highlight key areas of text. To do this: left click, hold and drag over a section of text; let go and a highlighter symbol will appear; click this to highlight the text.



You can de-highlight the text by left clicking the highlighted section again.

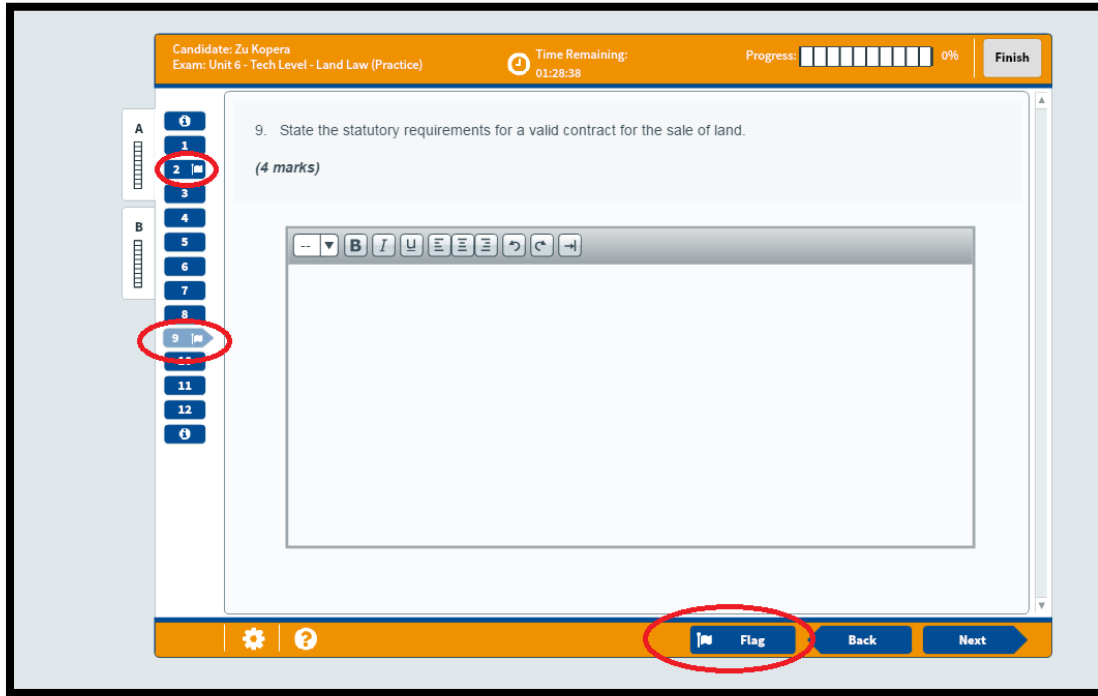
Crossing out answers

You can eliminate an answer by right clicking it. This will draw a line through the answer. To remove the strikethrough right click the answer again.



Flagging Questions

You are able to use the flag system to place a flag next to questions that you are not sure about or would like to review later on in the examination. This can be used as a method of managing your time during the examination.



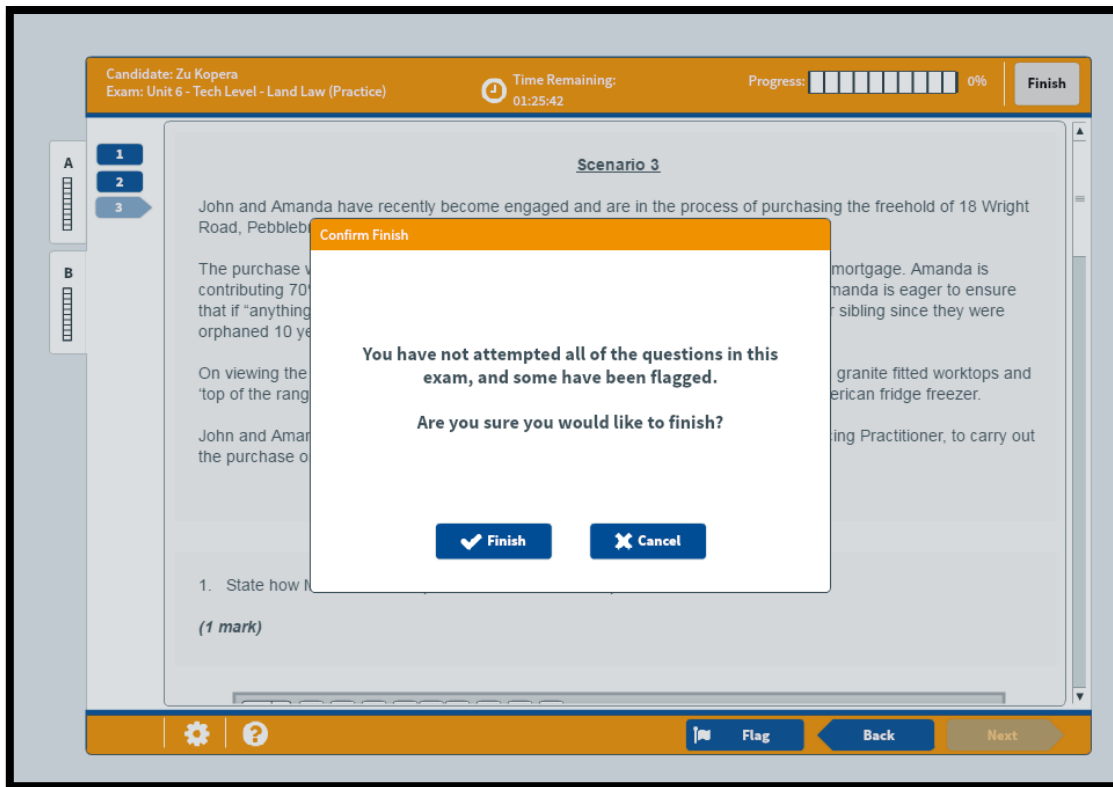
To add a flag click the flag icon at the bottom of the screen. This will add a flag alongside the current question number on the left side of the screen.

To remove a flag click the same icon and the flag will be removed from the current question.

If you try to finish the examination with a question still flagged (even if it is completed), a warning message will appear.

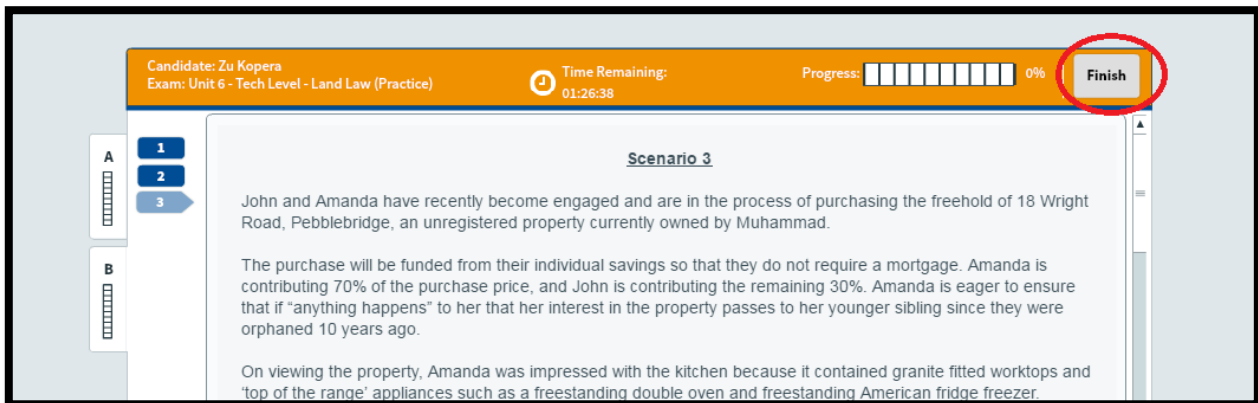



Use the 'Invigilate' screen to view and manage current examinations. You can also use features on this screen to control learners' access to examinations. You will find the Invigilate Screen in 'Test Administration'.


This screen will show each of the learners that are scheduled to take an examination at your centre, along with their Keycode and the PIN that they will need to access the examination. It will also specify the start date, the start time, the duration allowed and the status of the examination.

This screen will show you when a learner has started the examination, if the examination has been paused and when the learner has finished an examination. You are able to show only today's examinations by ticking the box shown in the top right corner (shown below).

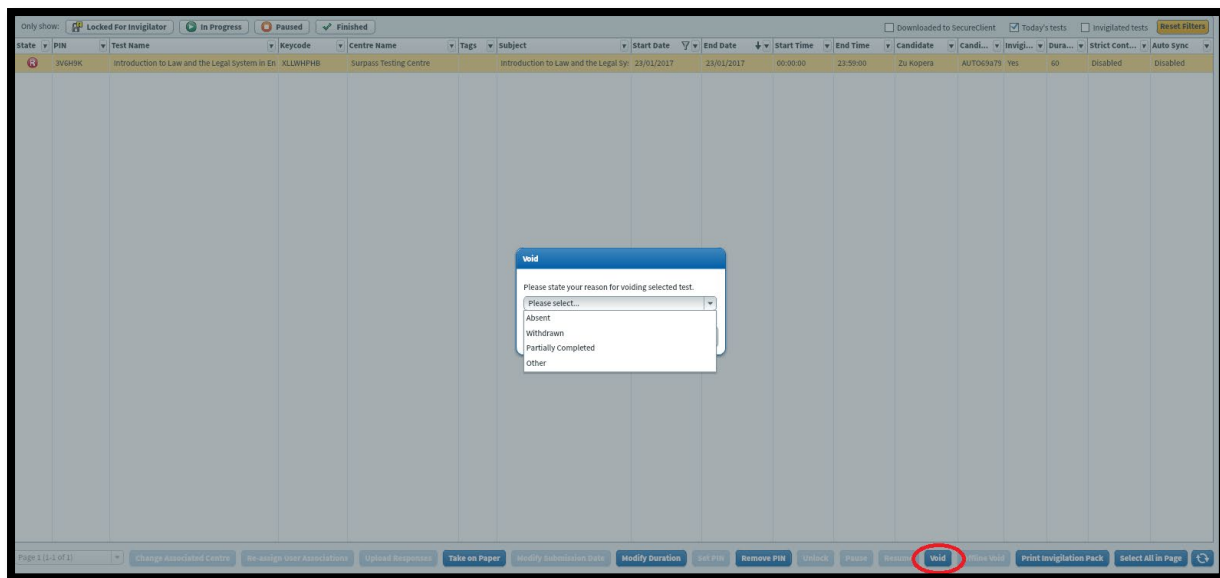

'Locked for Invigilator' – The learner has entered their Keycode and is waiting for the Invigilator to unlock a test.	
'Locked by PIN' – The test cannot be started until the learners enter the correct PIN. The learner must enter their keycode first.	
'Ready' – The test is ready to be taken by the learner.	
'In Progress' – The test is currently being taken by the learner.	
'Paused' – The test has been paused by the invigilator.	
'Awaiting Upload' – The test has been downloaded in advance, sat using the SecureClient and is finished but not yet uploaded back to Test Administration Central.	
'Finished' – The learner has finished taking the test.	
'Voided' – The test has been voided by a member of staff.	

From the Invigilate screen, the invigilator is able to do several things during the examination itself. You must be very careful when altering settings or applying these actions as they will affect live examinations.

Voiding papers

You are able to void a paper (if a learner has failed to show for example) by selecting the learner and then clicking 'Void' which is found at the bottom of the screen (circled red).

You will be asked to provide a reason before confirming the selection. Once void, you are unable to re-instate the learner so please bear this in mind for late arrivals.

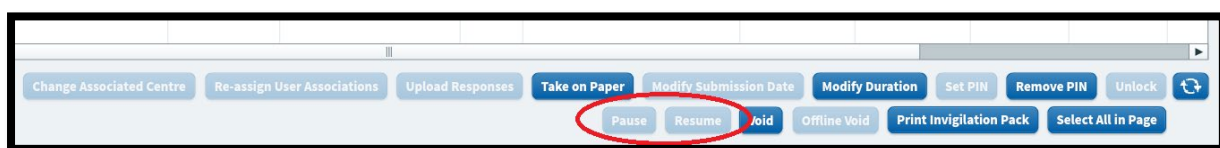


You are also able to pause/un-pause a learner’s examination. This will stop the timer on their paper and not penalise them. This is often used for supervised breaks, for example, for learners who require Reasonable Adjustments. It can also be used if there is an emergency that requires evacuation of the examination room.

To use this on a single learner, simply select the learner and click ‘Pause’, or to un-pause click ‘Resume’ (circled in red below).

To use on multiple learners, hold Ctrl on the keyboard and select all those affected by left clicking on each with your mouse. Then click ‘Pause’, or to un-pause click ‘Resume’.

To use this on all learners, left click with the mouse on the learner at the top of the screen, then hold Shift on the keyboard and then left click with the mouse on the learner at the bottom of the list. Then you can click ‘Pause’, or to un-pause ‘Resume’ and it will apply it to all.



Extend the duration of an exam

An Invigilator is also able to extend the duration of the examination if necessary. This is usually only required if the learner has a Reasonable Adjustment agreement that allows for extra time that is over the normally 25%. This would be communicated to the centre before the day of the examination.

If the learner does not have a Reasonable Adjustment Agreement, the invigilator must only extend the time allowed in exceptional circumstances (eg. an evacuation has taken place and they were not able to pause the exam).

To extend the time allowed for the examination, you select the learner by left clicking their name and then left click 'Modify Duration'. You will be asked to provide a reason for this selection and you may be asked by CILEx later for your reasoning.



If any of these actions (such as pausing exams or extending time limits) have been taken, you will have to record them in the Invigilation Report provided in the Invigilation Pack. Any issues arising from learner behaviour or technical issues should also be logged on the Invigilation Report.

Appendix 6 - Overall Results and Certification Guidance

Learners must be registered at the beginning of their course. Centres should email the completed qualification registration form to legalsecretaries@cilex.org.uk.

Assignments successfully achieved should be claimed by completing the unit claim form and emailing it to legalsecretaries@cilex.org.uk; component numbers must be entered followed by P (Pass); M (Merit); D (Distinction).

For the Level 2 qualifications for Legal Secretaries, once learners have achieved all necessary assessments, full qualification certificates can be claimed. The learner **must** pass the assessment for The Legal Environment and for Proofreading in the Legal Environment (if undertaken). The **overall grade** for the qualification should be calculated using the conversion chart below.

Full certificates are only issued to learners who have met the full requirements of the qualification(s). Certificates will be issued within 30 working days of making a qualification claim or 30 working days from the point of a successful External Quality Assurance Review (EQA).

Combination rules for grading full qualifications

Each assignment result is awarded points. A minimum of a **Pass** must be obtained in each assignment.

Appendix 16 – Proofreading in the Legal Environment Guidance

Proofreading in the Legal Environment is assessed by a dated examination which is available in four series each year, February, May, July and November. These dates can be found on our [website](#).

How to register for the examination

All candidates must register for the Proofreading examinations by the end of the month prior to the exam month. For example, if the candidate wishes to sit the examination in May, they must have registered by the end of March.

All registrations must be submitted via an Examination Registration Form and emailed to legalsecretaries@cilex.org.uk.

How to run the examination

All examinations and assignments must be run in compliance with the JCQ Guidelines – *Instructions for conducting examinations*.

Candidates are **allowed** to use English, legal or mother tongue dictionaries to assist them in these examinations.

The examination is formed of two parts. The Level 3 examination is 60 minutes in length.

What to expect in the examination

Candidates who sit examinations will be tested on proofreading text from an article or an extract from a legal document. These extracts, documents or text can be on any subject – but they are generally always related to the legal world in some way or are similar to documents they may encounter in the real working world. We continue to test candidates on their proofreading capabilities within the content of these documents.

Please note: Legal documents will appear in some of the examinations throughout the year and centres should advise their learners of this. CILEx do **not** test candidates on the layout of these legal documents.

Marking Criteria

At level 3 the candidate is assessed on the ability to identify and amend spelling, punctuation and consistency/grammatical/presentation errors.

Part 1 contains two passages which require candidates to compare and identify **fifteen** errors. To pass Part 1 candidates are expected to identify a **minimum of 75%** of the errors contained in the first passage from **each** of the listed areas.

Part 2, a document, contains **thirty-five** errors. Candidates are required to circle all the errors that they can find **and** write the correct answers in the adjacent margin. To pass Part 2 candidates are expected to identify and correctly amend a **minimum of 75%** of the errors in the document from **each** of the listed areas.

Results for candidates circling **43 or more** potential errors will be void as confirmation of their ability to correctly identify errors would not be possible.

Grading

Proofreading in the Legal Environment is graded pass/ fail only. Failure to achieve the minimum percentage from each area in Part 1 or Part 2 will result in an overall fail grade.

Results will be sent to centres within 7 weeks from the date of examination.

Appendix 17 – Legal Terminology Guidance

Legal Terminology (Unit 327) is assessed by a dated examination which is available on demand throughout the year. They are externally set and externally marked examinations.

How to register for the examination

All candidates must register for the Legal Terminology examinations by the end of the month prior to the exam month. For example, if the candidate wishes to sit the examination in May, they must have registered by the end of March.

All registrations must be submitted via an Examination Registration Form and emailed to legalsecretaries@cilex.org.uk.

How to run the examination

The Legal Terminology examination must be held within 2 weeks of receiving the materials from CILEx and in compliance with the JCQ Guidelines – *Instructions for conducting examinations*.

Candidates are **not allowed** to use English, legal or mother tongue dictionaries to assist them in these examinations.

The examination is 60 minutes in length.

Completed papers must be returned to CILEx for marking.

What to expect in the examination

Candidates are assessed on the ability to identify the meaning and terms used within legal terminology. Expand legal abbreviations, match Latin terms to their descriptions and identify correct spellings of legal terminology.

Grading

Legal Terminology is graded pass/ fail only.

Results will be sent to centres within 7 weeks from the date of examination.
