## **Question 1**

Reference: Question relates to **Document 1** of the case study materials.

Mr Andrews has prepared a letter to Sinead's doctor, Dr Fagan, requesting a report on Sinead's testamentary capacity.

(a) To assist Dr Fagan, draft a note to accompany the letter, explaining the common law test in <u>Banks v Goodfellow</u> (1870).

(6 marks)

Dr Fagan has now telephoned to say that she is confident that Sinead has the capacity to make a Will, and that she will confirm this in writing over the next few days.

Mr Andrews asks you to assist with the preparation of a draft Will.

- (b) Explain:
  - (i) what provisions need to be included in the Will to accommodate the fact that Sinead is blind;

(6 marks)

(ii) what steps will need to be taken when Sinead executes the Will.

(4 marks)

(c) Draft the clause for the gift to the Royal National Institute of Blind People (RNIB).

(6 marks)

#### **Question 2**

Reference: Question relates to **Documents 2 and 3** of the case study materials.

Assume, for the purpose of this question, that Alice's Will is valid.

(a) Identify the type of legacy contained in clause 4 of the Will **and** explain whether or not it will take effect.

(6 marks)

(b) Identify which grant of representation is appropriate in relation to Alice's estate **and** explain who is entitled to apply for it.

(8 marks)

The appropriate grant of representation has now been obtained.

(c) Identify any **seven** steps that will need to be taken in order to complete the administration of Alice's estate.

### **Question 3**

Reference: Question relates to **Documents 4 and 5** of the case study materials.

- (a) Having examined Tina's Will, explain:
  - (i) how Tina's estate will be distributed;

(10 marks)

(ii) why it will be distributed in this way.

(b) Identify which is the appropriate IHT form to send to HMRC in relation to Tina's estate **and** explain why this is the case.

(8 marks)

(c) Identify what you will need to submit to the Probate Registry in order to apply for the grant of representation in relation to Tina's estate.
