#### **SECTION B**

#### Scenario 1

One day, Cheng asked if Sam would lend him a large sum of money. Sam said he had no money. Cheng replied, 'You'd better find some quickly or that lovely girlfriend of yours will lose her good looks forever'. Sam could not bear the thought of his girlfriend being hurt, so he decided to steal the money from his employer.

Sam worked in the office of a construction company and he knew that, on pay day, the firm's Wages Clerk often left the employees' wage packets on her desk when she went for lunch. The next day was pay day and Sam entered the wages room at lunchtime intending to take the wage packets. As Sam was walking towards the Wages Clerk's desk, he heard someone approaching the wages room and he quickly left and ran out of the building towards town.

While running, Sam tripped over a brick which had fallen from a low garden wall onto the pavement. In anger, Sam picked up the brick and threw it over the garden wall. The brick smashed a large garden ornament.

Further down the road, Sam saw a box which had been left outside the door of a charity shop. Sam took the box, hoping it contained something valuable to sell so he could give the money to Cheng. The box contained old hats being donated to the charity shop.

#### Scenario 2

Dele had his employment terminated by his employer, Music Mania, after one of his colleagues told his manager that Dele was lazy and rude to customers. Dele did not know which of his colleagues, Victor or Martin, had told the manager, but Dele decided to take revenge on both of them.

First, Dele decided to poison Victor. During a tea break he poured some poison into Victor's tea, believing and intending the dose to be fatal. In fact, the dosage was too small to kill. Victor had been having marital problems and had recently separated from his wife, Olga. The separation had been hostile and unfriendly. Olga also wished Victor dead. Unknown to Dele, the same day that Dele poured poison into Victor's tea, Olga went round to Victor's house and put a similar dose of poison in the milk bottle on his doorstep. Victor later had a drink of the milk from the bottle. The cumulative effect of the poison killed Victor.

After Victor's death, Dele turned his attention to Martin. Martin is a keen motorcyclist who rides his motorcycle everywhere. Dele cut the brake cables on Martin's motorcycle, intending the motorcycle to crash. As soon as Martin began riding the motorcycle, he lost control because the brakes failed. The motorcycle crashed into a bus stop, but Martin was unharmed in the crash.

Unfortunately, the motorcycle knocked down a young girl, Tina, who was waiting for a bus. Tina died instantly from the injuries she sustained in the crash.

#### Scenario 3

Leo was a live-in carer for his younger brother, Vlad. Vlad had been born with serious physical disabilities and learning difficulties. He needed constant care. Once their parents grew old, Leo became the primary carer for Vlad. While Leo deeply cared for his brother, at times he would leave Vlad alone in the house while he went out with his friends. Leo knew that Vlad found being left alone stressful but Leo said he needed his free time too.

One evening, Leo went out to a party with a friend, Tom. He knew he should have returned home in the evening to check on Vlad and to give him his evening medicines, but he was having a great time and did not want to leave in the middle of the party. Leo decided to stay out, and he only returned home the next afternoon. When he arrived home, he found Vlad unconscious on the floor. Vlad had suffered a seizure due to missing his medication and he had collapsed. Leo called an ambulance but the ambulance took two hours to arrive. When it arrived, it was too late. Vlad had died.

Leo felt guilty that he had stayed out all night and he blamed Tom. The following week, Leo saw Tom in the street and hit him. Tom, fearing that Leo would seriously injure him, punched and kicked Leo repeatedly. Leo had to be taken to hospital. On examination, it was discovered that Leo's jaw had been broken.
