#### **SECTION B**

There are three scenarios — you must choose one scenario and answer all questions relating to that scenario.

#### Scenario 1

David and Eddie met 10 years ago and became civil partners shortly afterwards. They lived together in a modern, spacious flat in London, which was registered in their joint names. Both David and Eddie work in the music industry, and are both aged 43. When they became civil partners, they signed an agreement, according to which they would not make any financial claims against each other should their relationship come to an end. David and Eddie separated recently, after Eddie admitted that he had fallen in love with another man. Eddie has now moved into his brother's house.

Five years ago, Eddie was in a serious car accident, suffering injuries that left him unable to drive or work full-time, and in need of regular physical therapy. He has had two operations since the accident and may require further surgery. The flat owned by David and Eddie was adapted for Eddie's needs after the accident. Living at his brother's house is proving difficult for Eddie, as he finds climbing stairs painful.

David has remained living in the flat he owns with Eddie, which is valued at £1.5 million. When the flat was purchased, David and Eddie both contributed to the deposit from their work savings, and Eddie put in an additional sum of £100,000, which he had inherited from his grandmother. The flat has a mortgage of approximately £500,000. Both David and Eddie have pensions.

While going through some belongings that Eddie left in the flat, David has found a marriage certificate, indicating that Eddie was married in 2002 to a woman named Carla. David remembers hearing Eddie talk about someone named Carla but had no idea that they were ever married. David has searched for any evidence of their divorce, but without success.

#### Scenario 2

Ben, 55 years old, and Jogeeta, 50 years old, have been married for 30 years. They have three children over the age of 18 years. All the children have left home, apart from Peter, who is a university student. Ben, Jogeeta and Peter live in the family home, a five-bedroomed detached property, which is valued at £500,000 free of mortgage.

Ben is a successful insurance broker earning £100,000 a year, receives bonuses and has a private pension. Jogeeta, a former secondary school teacher, gave up her career on the birth of their first child, and has since stayed at home and cared for the children. Jogeeta would like to return to work, but feels that having been away from the workplace for so long will make returning very difficult.

Ben and Jogeeta are not happy. For the last two years they have been leading separate lives. They have been sleeping in separate bedrooms, doing their own shopping, cooking and cleaning. Ben has recently admitted that he is having an affair with a female work colleague, which Jogeeta had suspected.

Jogeeta wants a divorce, but wants to remain in the family home. Ben is agreeable to the divorce but wants the family home sold and the proceeds divided.

#### Scenario 3

They have two children, Florence (aged 15) and Hector (aged 5).

Last year Victor met Dino and formed an intimate relationship with him. Six months ago, he moved in with Dino and they are currently living in Dino's rented flat.

Charlene and the children have moved out of the family home and are now living with Charlene's new boyfriend, a wealthy footballer. Victor has put the family home up for sale. He has recently received a letter from Charlene, saying that she wants half the sale proceeds.

Since Victor has been living with Dino, Charlene has prevented him from having any form of contact with the children. Charlene even returned the birthday cards that Victor sent to the children. Victor managed to speak to Florence on her mobile phone a couple of times, but when Charlene found out, she took away Florence's mobile phone.

Victor has heard via mutual friends that Charlene has told the children that Victor left them because he does not love them. Hector has become withdrawn; he told his teacher that his daddy left because his daddy hates him. Florence, however, says that it is all Charlene's fault and has threatened to run away.
