Reference: Question relates to **Documents 1 and 2** of the case study materials and is concerned with the **Holly Graves file**.

(a) Explain, with reasons, whether the Pre-Action Protocol for Low Value Personal Injury Claims could be used in this case.

(4 marks)

(b) Explain the procedure to be adopted in Holly's case, if the Pre-Action Protocol for Low Value Personal Injury Claims is not used.

(5 marks)

The procedure adopted is not successful and proceedings are issued on behalf of Holly Graves.

(c) Explain which factors the court will take into consideration when allocating this case.

(7 marks)

As expected, the case is allocated to the Fast Track.

(d) Explain how directions will be dealt with and list **three** relevant directions that would apply in this case.

(4 marks)

(Total: 20 marks)

Reference: Question relates to **Documents 1 and 3** of the case study materials and is concerned with the **Space Babies Clothing Ltd file**.

(a) Draft the key points of the Defence Statement on behalf of Space Babies Clothing Ltd.

[NOTE TO CANDIDATES: Do <u>not</u> draft the formal parts of the Defence, such as headings.]

(6 marks)

You file the Defence, but in your opinion the Claim is weak and you consider making an application for Summary Judgment.

(b) Explain the possible outcomes of an application for Summary Judgment.

(5 marks)

You decide not to make an application for Summary Judgment, and the case, having been allocated to the Multi-Track, proceeds to trial. At trial, Space Babies Clothing Ltd is successful in defending the claim.

(c) Explain how the matter of costs would have been dealt with throughout the case up to, but not including, the final hearing.

(5 marks)

Reference: Question relates to **Documents 1 and 4** of the case study materials and is concerned with the **Richard and Kerry Temple file**.

(a) Explain whether the Defendant is required to provide a list of documents.

(5 marks)

The Defendant's solicitor is forthcoming with a list of documents and the matter proceeds to trial. The Listing Questionnaire (Pre-Trial Checklist) needs to be completed.

(b) Give **four** examples of the matters considered in the Listing Questionnaire.

(4 marks)

Richard and Kerry Temple are successful at trial. However, the Defendant, Frank Harvey, has failed to pay the judgment debt.

- (c) Advise Richard and Kerry Temple of the best way to enforce judgment in the following separate circumstances:
 - (i) the Defendant owns a house;

(2 marks)

(ii) the Defendant has a collection of vintage cars;

(2 marks)

(iii) the Defendant has substantial savings in his bank account.

Reference: Question relates to **Documents 1 and 5** of the case study materials and is concerned with the **Zofia Kowalski file**.

(a) Explain **two** potential methods of funding that would be appropriate in the circumstances.

(4 marks)

(b) Explain whether Zofia Kowalski has to prove that the faulty wiring caused her injuries and, if so, to what standard.

(2 marks)

Unfortunately, the matter cannot be resolved through the Pre-Action Protocol, and you are instructed to issue proceedings.

(c) Identify the documents you will need to send to the court, in order to issue proceedings.

(4 marks)

A Defence is filed, denying liability. The Defence is confused in places.

(d) Outline the procedure you will adopt to clarify the Defence.

(5 marks)

The matter proceeds to trial and your client is unsuccessful.

(e) Explain how the matter of costs will be dealt with by the court, assuming that Zofia Kowalski paid from her own resources for your firm's services.

(4 marks)
