I have been consulted by Olga King, a long-standing client of the firm.

Olga is 68 years old and is starting to worry that she has not thought about any inheritance tax planning. When her brother Ben died, his estate paid a very large amount of inheritance tax and she is keen to reduce her own potential inheritance tax bill. She is considering the use of a trust, but is worried about all the tax implications.

Olga has never married or had children. She is very close to Ben's only child, Jessica, and Jessica's son, Luke (aged 9). Jessica is a recovering gambling addict. She has not gambled for six months, but Olga would not want to make large outright gifts to her now, because she thinks it is too soon to say that she has overcome her addiction. Luke is extremely intelligent and wants to be a vet.

Olga provided a list of her assets (**Document 2**). She told me that in relation to the holiday home, she stopped using it six months ago after breaking her hip, as she finds it impossible to use the stairs. Her physiotherapy is going well but she thinks that, in the future, she will only use it for one week every year, if at all. She does not want to sell it, as Jessica and Luke love it and spend most school holidays at the property. Olga has started to think about renting it out.

Ben needed long-term care, so Olga is nervous about giving too much money away too soon. She has never made any gifts.

The only people she wants to give money to (both in her Will and during her lifetime) are Jessica and Luke.

I have been consulted by Karl Zhang in relation to the estate of his friend, Bill Grey, who died three weeks ago. Bill left a valid Will appointing Karl as his executor (**Document 4**).

Karl knows that all of the beneficiaries survived Bill. Karl has spent the last three weeks gathering details of the estate and is satisfied that the estate can pay its liabilities and expenses. Bill's house, 'Whiteacre', has been valued at £435,000 and is subject to a mortgage of £280,000. The holiday home has been valued at £180,000.

The residuary real estate includes a separate plot of land in Kent. This is the subject of a mortgage of £160,000, which is also secured against the holiday home.

Karl knows that Bill had £28,000 in his savings account with Diamond Bank, and other personal and cash assets valued at approximately £1,000.

Karl states that there is no mention in Bill's Will of the funeral and administration expenses. Karl has paid the funeral account from the savings account that Bill had with Diamond Bank.

Bill had credit card liabilities of around £4,500 and a number of other unsecured debts amounting to about £8,000. Karl is not yet clear whether there are any further debts, but he is satisfied that the estate can pay them if there are.

Sam had a beautiful antique red vase that was his pride and joy. Last year, he dropped it and Patricia bought him a similar vase as a replacement.

All but two of the beneficiaries are alive. Patricia's only child, Rachel, died last year and Quinn died 18 months ago. Quinn's widow, Elizabeth, is still alive. So too are his two adult children, Greta and Ian, and Greta's child, Hannah (aged five).

The estate is not subject to inheritance tax and is an excepted estate for probate purposes.

Later in the same year, Fatima met Henry Jet, who was six years senior to her and was also recently divorced. Henry had previously been married to Zoe, but there were no children of that marriage.

Fatima and Henry lived together and in 2019 had a daughter, Emily, and the couple subsequently married two months ago. When returning from their two-week honeymoon, Fatima and Henry were killed in an air crash. The order of deaths could not be established. Both Fatima and Henry made new Wills prior to their divorces, disinheriting David and Zoe respectively. Fatima left her estate to Sarah and Craig; and Henry left his estate to charity.
