The Chartered Institute of Legal Executives is required to undertake such visits to ensure that a Training Provider has met and can maintain compliance with the CILEx Training Provider Accreditation Standards. The visit was conducted in accordance with the CILEx Accredited Training Provider Handbook (2019).

#### PART 2

### **Background**

The University of Derby has applied to deliver the CILEx Level 3 qualifications and the CILEx Level 6 qualifications as part of their delivery of the Paralegal and Chartered Legal Executive Apprenticeships. The University of Derby does not currently deliver any CILEx provision.

### **PART 3 Visit outcomes**

The Panel found that the Training Provider has met 28 out of the 29 organisation standards and all 32 programme standards.

The Panel has decided that accreditation should be awarded with one condition.

### Condition

Standard 2.3	The Training Provider demonstrates a clear approach to identifying
	and managing conflicts of interests, whether potential or realised.
Condition	The Training Provider must develop a conflict of interest policy and
	process, in accordance with paragraph 4.13.1 of the CILEx

	Accredited Training Provider Agreement; and provide evidence of
	both the policy and process.
Deadline	31st December 2019

#### Rationale

The Panel were notified that the Training Provider has a number of ad hoc conflicts of interest policies in place, and that furthermore the relatively small number of staff, coupled with the culture of transparency, frequently allows conflict of interest issues to be resolved without a formal process. However, The Panel felt that in order to protect both CILEx and the Training Provider, must have a formal conflict of interest policy in place which prompts staff to declare any conflicts on an annual basis, or if one occurs outside the annual monitoring cycle.

Standard 2.3 requires Training Providers to demonstrate a clear approach to identifying and managing conflicts of interests, whether potential or realised. This requirement includes the provision of a conflict register.

The Panel requires the University of Derby to provide documentary evidence for their conflicts of interest policy, process and register by 31<sup>st</sup> December 2019.

### **APPENDIX B – Update on condition set and accreditation status**

One condition was set at the Accreditation Visit which took place on 15<sup>th</sup> October 2019. Details are provided in Part 3 above. This related to Organisation Standard 2.3.

The condition required the Training Provider to submit documentary evidence, in the form of a conflicts of interest policy and process, to demonstrate that potential conflicts of interest are identified and managed effectively. In addition, the condition requested the inclusion of a conflicts of interest register.

This evidence was received by CILEx on 17<sup>th</sup> December 2019 and was considered by the Panel. It was agreed by the Panel that the evidence submitted was sufficient to meet the condition set.

Compliance with this standard, and all other standards, will be monitored as part of CILEx's ongoing quality assurance process.

The University of Derby is awarded accreditation without any conditions.
