Cristina grew up in a small village near Bedford. She left school at 16 with few qualifications and moved to Bedford to obtain work. She got a clerical job with Robyn Kitchens Ltd, a large company that manufactured kitchens, and met Aleksander, who was a sales executive for the company.

Cristina and Aleksander got on well and moved in together. In June 2003, they got married. A family followed when Georg was born, and then Harri.

Aleksander was very good at his job and quickly gained promotions. This enabled him to buy a four-bedroomed family home nearby. Cristina was able to stay at home with the children and they settled happily into village life.

A year ago, Aleksander was offered the job of national sales director. The job involved working from an office based more than 150 miles away in Manchester and regular travel around the country. Cristina did not want to move as the children were settled in their schools and doing well, and she had family and friends nearby.

Aleksander promised Cristina that they would not have to move and he would manage the travelling.

After six months in the job, Aleksander told Cristina that the travelling was too much for him and that he needed his family to move to Manchester. Cristina was very unhappy. This led to arguments whenever Aleksander was at home.

Aleksander is currently living in Manchester. His address is Flat 12, City House, Lynx Road, Manchester, M59 9XZ.

The additional information that you requested, concerning our finances is:

Family home – 12 The Ridings, Kempston:

This was bought in Aleksander's sole name. It is currently worth £550,000. The mortgage outstanding is £175,000.

Aleksander's job:

Aleksander is currently earning £245,000 per annum. He also receives an annual bonus, which is paid in March. The bonus for 2016 was £75,000.

Aleksander's pension:

Julie attended with her mother, Mrs Dorothy Hunt.

Julie is a partner in a large accountancy practice. Her job is very demanding but until recently she has remained close to her family, and made a point of never missing family occasions.

However, she found little time to socialise and go on dates. Two years ago, she decided to join an internet dating agency and met Nick, an apparently successful businessman. After a whirlwind romance, they flew to a Pacific island and were married in a quiet ceremony with only two local witnesses. No family were invited.

On their return they set up home in the house that Julie had bought some years earlier. It was near her parents, but Julie and Nick rarely visited them. On the rare occasions when Mr and Mrs Hunt saw Julie, she seemed very withdrawn and undemonstrative, quite unlike the daughter they knew.

Last week, Mrs Hunt was out shopping and bumped into Julie. Mrs Hunt persuaded Julie to have a cup of coffee with her. Julie finally opened up and admitted that Nick was not in fact a successful businessman. Nick had no money and no job. Julie had also quickly discovered that he was very possessive and controlling. The facts are as follows:

Isaac and Tina met at college. They completed their courses in 2004, obtained jobs and set up home together. A year later they had a daughter, Sami. Isaac was registered as Sami's father. Tina found being a young mother hard work, particularly as Sami was a difficult baby. The stress affected her relationship with Isaac and they decided to separate when Sami was 3 years old.

Shortly after the separation, Sami was diagnosed with a medical condition which will weaken her muscles as she grows older. She is receiving medical treatment for the condition, but so far the condition seems to have had little effect on Sami.

Tina became very protective of Sami following the diagnosis and insisted on keeping full control of all aspects of her life.

Recently, Isaac has learnt that Tina has not been informing him of Sami's hospital appointments, which he has always tried to attend.

Last weekend, Sami told Isaac that her consultant is conducting a trial using a revolutionary new treatment. Tina has agreed to allow Sami to take part. Sami is not keen as she says that she heard the consultant say that it will involve daily trips to hospital for several weeks, during which time she will not be able to stay with her dad.
